I CALL TO ORDER

Laylee Rohani, Chair, called the meeting to order at 5:00 pm.

II APPROVAL OF THE AGENDA

The agenda was approved as distributed.

III BOARD MEMBER REPORTS

1. Chair's Report

Laylee Rohani, Chair, noted next year is the college's 50th Anniversary. The Victoria/Southern Vancouver Island CPA Chapter Chinese New Year Dinner and Silent Auction took place on February 13. Thank you to all the board members who attended, and supported the fundraiser that benefits Camosun College students: 'CPA Award in Accounting'. Sherri Bell and Laylee met several times for planning. Joanne Cumberland is the recipient of the 'Region 8 Conference Scholarship' from the National Academic Advising Association. Their annual Region 8 conference will take place in Victoria in March, and Joanne will be presenting: 'If Advising is teaching, do we know everything we are teaching?'

2. President's Report

Sherri Bell, President, distributed brochures on the S'tenistolw conference. It will take place at the Lansdowne Campus in August, and the focus is on Indigenous education. Camosun Innovates received close to \$1M from the Canada Innovation Fund. It will go to buy equipment and renovate space to expand Camosun Innovates. Richard Gale, Director, Camosun Innovates, was interviewed by CBC on his project to scan in 3D the 'Witness Blanket'. His team went to the Human Rights museum in Winnipeg to do the work.

Sherri Bell held a presentation at each campus in March to update employees on large projects and policies that are underway. The annual 'Conversations Day' was held during reading break. All employees attend. Silken Laumann was the speaker, and the theme was resilience. Sherri met with MPs Laurel Collins and Randall Garrison. She gave Mr. Garrison, who taught at Camosun previously, a tour of the new health building. She will give Laurel Collins a tour of the Interurban campus next week.

BC Colleges Day was last week. Camosun hosted the ten presidents from BC Colleges (BCC) last Monday. Sherri is the Chair of BCC. On Monday evening, the MLAs from all sides were invited to a reception to meet with the presidents. On Tuesday, they had breakfast with Minister Melanie Mark, who talked about the new Access Grants, which are geared to colleges.

Tanya Clarmont and Ron Rice invited Sherri to an urban reconciliation dialogue at the Saanich Fairground, and Sherri took part on the panel. It was a wonderful event and continued on Saturday. It was live streamed. Tanya will send the link to the board.

The College Executive Team, Facilities, and the Emergency Manager are working on plans to address Covid 19, which will have an impact on us. The college has to do what the health authority directs us to do. Sherri's joint trip with the school districts to Japan this week was cancelled. The BC Council for International Education (BCCIE) worked with SFU for the last two years on the Asia-Pacific Association for International Education (APAIE) conference in Vancouver in March. It has just been postponed until next year.

3. Foundation

Geoff Wilmshurst, Vice President Partnerships, noted they last met on February 27. They reviewed their Strategic Plan. Ongoing fundraising in 2019 was \$1.6M, up from \$1.23 in 2018. They increased the number of donors by 19%, and the average amount was increased 77%. The Health Campaign is at \$4.5M, and the goal is \$5M to meet our obligation to the Province. A lot of communication is going on with alumni, including the bi-monthly alumni newsletter, and enhanced presence on Twitter and Instagram. We held Chargers alumni nights, and had about 150 alumni and family attend. We lead the charge on Camosun's participation in Discover Tectoria, VIATEC's showcase of industry talent. We just concluded a successful audit by KPMG. Jody Kitts and Dana Henley are restructuring the Foundation's Raisers Edge database. We are looking for potential sponsors for the S'tenistoly conference.

4. Education Council

Bijan Ahmadi, Education Council Chair, noted the minutes from the December 11, 2019, meeting were included in the agenda package. The January meeting was canceled due to snow. Bijan

went over the highlights of the February 19, 2020, meeting, which included curriculum approval of new programs for the September term.

5. Pacific Institute for Sport Excellence (PISE)

Phil Venoit, PISE Board of Directors member, advised the Active for Life Programs for Community Health has been invested in heavily by the school district. It was very well received, and will be expanded to the Gulf Island school district this year. Performance Pathway Athletes and Sports is beginning to focus on females in sport. They will create a rugby and softball program this year. Work on the gymnasium will begin in April, and will include new bleachers, resurfacing the floor, new floor lines, and new retractable hoops. Rob Bettauer is working on the long-term space agreement with Saanich Commonwealth Place, with the goal of maintaining the current use in the space.

IV BOARD COMMITTEE REPORTS

1. Executive Committee

Laylee Rohani, Chair, Executive Committee, noted we met last week. We discussed the planning for Camosun's 50th Anniversary, which is coming up in 2021. We will work on it together later today. The Board Executive received an update on Campus Renewal. We reviewed the process for student housing. We looked at a refresher from Robert's Rules of Order on the way we handle motions.

1. 2020/21 Government Mandate Letter

Each year the Government gives Camosun College a mandate letter for the upcoming year. Jennifer engaged with the College Executive team, the Senior Leadership Council and the Operational Leadership Team for ideas, and the who, what, and why of the celebration. A key theme is telling Camosun's story: where we came from, where we are now, and looking towards

the future. We plan to celebrate with students, staff, and the community. The kick-off will be on February 19, 2021 at Conversations Day. TOPIC: BARGAINING UPDATE

ISSUE

The terms and conditions of employment for unionized employees at Camosun College are governed by three collective agreements that expired in 2019. The collective agreement between Camosun College and the British Columbia Government Employees' Union was renewed for the term of April 1, 2019 to March 31, 2022. Contract negotiations will continue between Camosun College and each of the Camosun College Faculty Association and the Canadian Union of Public Employees, Local No. 2081, until tentative agreements are reached between the respective parties and memorandums of settlement are ratified.

Background:

A Briefing Note dated November 14, 2018, provided the Board with background information regarding Government's bargaining mandate; how proposals are developed and bargaining committees formed; the strategic roles of the Board, College Executive Team (CET) and Local Bargaining Committees; as well as bargaining progress to date. Board updates will continue to be regularly provided until bargaining has concluded for the remaining two Unions at Camosun College.

British Columbia Government Employees' Union (BCGEU) Common and Local Agreement: The BCGEU Common and Local agreements were ratified by the parties' respective principals on May 3, 2019.

Federation of Post-Secondary Educators of BC (FPSE) and Camosun College Faculty Association (CCFA)

-- Common and Local Agreements: The FPSE Template Table signed a protocol agreement and common table bargaining, which commenced in late October, continued in early January; and discussions have resumed this month to determine next steps. Local negotiations taking place during the Winter period were positive; however, face-to-face negotiations have been paused as a result of the challenging circumstances we are faced with in light of COVID-19. In PSEA's discussions with FPSE, they will also consider potential next steps with respect to local bargaining, given these extraordinary circumstances.

Canadian Union of Public Employees, Local No. 2081 (CUPE): Local bargaining has continued to be positive; however, face-to-face negotiations have paused in light of COVID-19. PSEA is in contact with CUPE to discuss next steps.
