

1. EDUCATION COUNCIL GROUP PICTURE

Jason King from Audio Visual took a group picture of the 2011-2012 council for our website.

2. CALL TO ORDER & DECLARATION OF QUORUM

The Regular Meeting was called to order at 4:08 by Kathy Tarnai-Lokhorst Education Council Chair.

3. ACKNOWLEDGEMENT OF COAST SALISH TERRITORY

Kathy acknowledged the Coast Salish Territory. Camosun College serves the communities of southern Vancouver Island and the south Gulf Islands that are located in the traditional territories of the Esquimalt; Lekwungen; Malahat; Pacheedaht; Pauquachin (Saanich); SC'Ianew; Tsartlip (Saanich); Tsawout (Saanich); Tseycum (Saanich); and T'Sou ke Nations. 4. ACCEPTANCE OF AGENDA

The Sept 26, 2011 agenda was accepted via a unanimous consent.

5. APPROVAL OF MINUTES

The June 20 2011 Regular Minutes and the Special Meeting Minutes were accepted as presented via a unanimous

consent.

6. INTRODUCTIONS & ROUND-TABLE CHECK-IN

Kathy requested members describe their mood/feelings that day as in one word to acknowledge and give voice to the emotional climate of the members.

7. EDUCATION COUNCIL CHAIR'S REPORT

Kathy noted that she attended the first Board meeting of the 2011-2012 academic year. The new chair of the Board is Kyman Chan. The past chair Lynda Farmer will be staying on the Board. The Board discussion focused on the College's new <u>Strategic Plan</u>. Kathy noted that Education Council, like the Board, will be looking to ensure all our activities for the upcoming year align with the Strategic Plan.

Kathy also noted that the Board reviewed Camosun's latest Institutional Accountability Plan and Report. The report notes such things as our institutional accomplishments & highlights, institutional overview, planning context (i.e. environmental scan, etc.), goals and objectives, and strategic objectives, performance measures and targets. Kathy noted that we did see some improvements in the report (i.e. in the area of literacy).

Kathy noted that Education Council currently does not have a Board Representative. She has requested that the Board appoint a Board to become the Education Council rep. This request is in process.

Kathy also gave a brief background on the various ad-hoc and standing committees of Education Council and asked if members wished to continue with the committee or if any new members were interested in joining a committee:

8. VP EDUCATION & STUDENT SERVICES REPORT - Baldev Pooni

Baldev advised Education Council members to keep their eyes open for a Cam News Article on Wednesday regarding the Strategic Plan. He noted that the article will note the nine (9) items identified in the implementation plan and the champions that will be leading them.

9. COLLEGE CURRICULUM COMMITTEE REPORT - Nicole Greengoe

Nicole briefed the council regarding a vacant seat on CCC for a student member.

Nicole presented the CCC report as follows:

a. Presentation – Proposed Certificate in Herbal Studies – Val Montague

Val presented the proposed Certificate in Herbal Studies. Herbal Medicine is the ancient use of plant remedies in the treatment of disease. Modern science now allows us to better understand their healing powers and how they can complement traditional medicine. The <u>philosophy</u> behind herbal medicine is to treat the person, not the disease. Our sixmonth part-time program educates students to safely create effective, simple, affordable herbal medicines for personal use, using sustainable practices. Students will:

- Learn how to identify and use local wild and cultivated healing herbs.
- Become knowledgeable in Western, Ayurvedic, and traditional Indigenous philosophy and their use of herbs.
- Create effective, simple, affordable herbal medicines for personal use and learn about sustainable herbal practices.
- Apply a holistic approach to health and healing with herbs using modern science to enhance and complement your knowledge, efficacy and safety

Students will explore traditional and western approaches of using herbs for different body systems and will compare and contrast commercially available herbal remedies. The program theory includes an introduction to the physical structure and systems of the human body. Legal and ethical considerations of practicing herbalism will also be discussed. The practical component of this program, "Learning on the Land", includes hands-on herb identification, harvesting, and medicine making for personal use. Students are also introduced to the western herbal approach of using herbs for different body systems and will compare and contrast commercially available herbal remedies.

As the herbal industry is not presently regulated, this credential provides validation that the student has received a quality education from a reputable public post-secondary institution. While many students will choose to attend for personal interest, this credential serves to raise the standard of the industry and helps to promote a broader acceptance of holistic medicine. This program provides a strong foundation for students to create herbal remedies for personal use and to apply their knowledge in a community setting. Students may pursue continuing education towards professional membership in the American Herbalist Guild.

b. Bachelor of Business Administration (BBA) Work Experience Courses

- 1. Reduce the number of BBA work experience courses from two (2) 360 hours courses to one(1) 420 hour course.
- 2. Cancel the current BBA work experience courses BUS 399 (360 hours) and BUS 499 (360 hours).
- 3. Replace the cancelled BBA work experience courses with new ACCT 499 (420 hours), or HRML 499 (420 hours), or MARK 499 (420 hours) depending on the student's BBA program.

The school notes that one work experience satisfies the work experience set by the DQAB and reduces the total length time to complete the BBA without sacrificing academic quality. Also, some limited work opportunities may cause the graduation of some students to be delayed because they cannot find a suitable second work term. Note that the change will also be consistent with the COOP 201 option in the program, which requires 420 hours, and thereby ensures equal work experience requirements for both coop and non-coop students. The school and Co-op will be working together to develop a communications plan to communicate the proposed changes to students. It is also the intent of the program to recognize students that have existing relevant work experience via the PLA route, and strongly recommend that students without work experience enrol in Coop.

Note that there was no consensus reached with regard to a recommendation for approval from the CCC due to an outstanding concern regarding the application of Prior Learning Assessment (PLA) for students that wished to use the PLA process for work gained while a student in the program. It was noted by some CCC members that this watered down our definition and process of PLA, that it challenged the value of Cooperative Education, and that there was a strong potential for confusion for employers in the community regarding whether they were employing a Camosun student enrolled in a work experience course or not. The CCC forwarded to Education Council for decision.

Questions and discussion followed. Note that Ian and Gloria answered questions or clarified information as requested.

Baldev noted that it is the College Administration's responsibility to find operational solutions for recognizing work experience that a student may bring into or complete while in a program or course. He will review the issue with the affected parties to find a solution

c. Associate Degree of Arts and Associate Degree of Science

Following a program review and renewal and based on data and feedback provided, revisions were made to the Associate of Arts and Associate of Science degree programs. Revisions were made to program description and learning outcomes, and the Associate Degree of Science admission requirements. It was also determined through this process that a number of the specific discipline options in the program would be cancelled mainly due to low enrolments. It was determined that it is more viable to put resources into the promotion of the Diploma of Arts and Science than a number of the Associate Degree discipline options, which are very restrictive re. program content/completion requirements.

d. HIST 290

Note that for pre-requisite and credential purposes the proposed version of the course is equivalent to the old version of the course.

<u>BUS 380</u> - Add 1 hour a week (from 3 to 4) to course hours to allow for greater time to explore themes and course content to a level where students are able to deliver projects and assignments that reflect the course requirements.

MARK 225 – Add 1 hour a week (from 3 to 4) to provide a greater grounding in Public relations writing, etc. and to make the course time consistent with other required and elective courses in the diploma and BBA programs. In addition, a learning outcome was added related to the development of public relations writing skills.

Education Council Awards Committee Report

REPORT

The Education Council Awards Committee received 3 nominations for this year's Lt. Governor's Silver Medal Award. The Lieutenant-Governor of British Columbia annually awards a medal to a student graduating from a one-year or shorter program. The recipient must have an excellent academic record and have contributed positively to the college or community at large.

The Awards Committee selected Charlene Caldwell as this year's recipient for the award. Charlene made notable contributions to college and community, and graduated in the Advanced Diploma in Human Resource Management program with a GPA of 7.3.

Charlene was nominated by faculty members Robin McQueen and Shari Corrigan in the School of Business. Shari notes that Charlene "has developed into such a strong leader among her peers (...) by assisting in the creation and development of the Camosun DECA Chapter (...) DECA prepares emerging leaders and entrepreneurs (...) but it also encourages chapters to develop a civic consciousness (...) as a founding member, Charlene assisted in the development of a chapter constitution and lobbied the Dean's office to support the chapter, the very first in Western Canada".

In addition to the founding of DECA, Charlene volunteered in the Choices Adoption Annual Art Auction, The Victoria Tea Festival, Camosun Open House, School of Business Orientation Day, First Annual DECA Leadership Conference, and various fundraising events for chapter members to offset travel costs to competitive events. Shari, in her letter of recommendation, concludes that "Charlene was able to maintain a strong academic performance while simultaneously committing countless hours of service to the college, her employer, and volunteer activities in the broader Victoria community. Because of this she is truly deserving of the Lt. Governor's Silver Medal Award".

Charlene noted in her own words that volunteering with DECA and as their Vice-President of Marketing and Recruitment allowed her the opportunity to "make a difference in the lives of the students".

In addition to her work with DECA, Charlene also volunteered for the Burnside Gorge Community Santa's Pancake Breakfast and for "goBEYOND" to put on a seminar about sustainability in the workplace and "enrich lives at Camosun College".

The Awards Committee proudly recommends Charlene Caldwell for the Lt Governor's Silver Medal Award.

1. Diploma in Indigenous Studies

Summary/Purpose

To increase the four (4) Circle Seminar courses in the program by 30 min. each from 1 hour to 1.5 hours a week to ensure students are given enough time to be heard. Current student feedback has indicated students don't feel that they have been allotted enough time. This also increases the course credits from 1.0 to 2.0, and the overall program credits from 64 to 68.

CCC Concerns/Questions/Comments

- 1. The CCC requested clarification on the justification for the additional 30 min. per week as it will increase the tuition for the course. The department has clarified that downside of the program cost increase is outweighed by students' need to have time to process the activities involved in circle learning.
- 2. The CCC requested the department redo the Calendar Descriptions to be more informative and better reflect the learning outcomes for the courses. The department has done.
- 3. The CCC requested clarification on how the department would PLA the courses. The department has clarified a process for assessing students for prior learning.
- 4. The CCC is challenged with the course being a 2.0 credit value given it is not clear if the additional 30 min. a week actually leads to an additional depth or breadth of learning or that the course outcomes even support it at a 2.0 credit value. The CCC, however recognizes that the increase in credits is a result of the credit model calculation which makes this increase (1.5 derived hours) round up to the nearest whole number. The CCC recommended the concern re. the credit model be forwarded to Baldev Pooni. This has been done.
- 5. The CCC requested some wordsmiths to the documents to improve clarity. The Department has done.

This brings this course into alignment with the other four research universities and gives students more flexibility as to when their math courses are taken.
