#### F. Reports

#### 1. Education Council Chair

**Carly Hall** 

Carly reported the Executive Committee reviewed the feedback received at the last Education Council meeting from the members concerned with the need for some additional information to be included with the ICC report to facilitate decision-making. The Executive Committee has altered the ICC report to include a very brief description of the curriculum change with the curriculum item. It is hope this will assist Education Council members in approving the curriculum changes.

2. VP Academic John Boraas

John reported on the upcoming issues regarding the Budget and the emergent announcement regarding funding cuts to the English Language Development programs.

3. Board Member Ian Cowan

Ian Cowan reported that Kathryn Laurin outlined the BC Government's Core Review process coming from the Ministry. The Core Review process is intended to ensure the best possible use of government resources and respect for the interest of taxpayers. It is being led by Bill Bennett, Minster of Energy and Mines.

John added that the Camosun is hoping to use existing measures and reports to report to the Ministry rather than adding an additional layer of review to the process. This will be explored further.

#### 2. Governance/Standards Issues Arising from Curriculum Review

**Karin Kaercher** 

The issues as follows were presented by Karin. Questions and discussion followed.

#### **Course Requisites Discussion**

The way in which pre-requisites, co-requisites, and pre-co-requisites are understood and used vary considerably across the institution. This is a significant issue and we need to seek clarity around the terms from an Educational Standards perspective. There was a will expressed at the meeting to table the discussion until a later date.

#### I. Presentations and/or Discussions

#### 1. ELD Funding Cuts

John Boraas

John discussed the ELD funding cuts by the Ministry of Advanced Education.

#### Excerpt from the Camnews Article released Dec 16, 2013.

The first area of concern is that a 30-year highly successful program will lose its funding impacting the 28 faculty and staff and nearly 2,000 students per year who enroll in our programs. It will not impact International Education as those students cover the actual cost of their programming.

We are extremely concerned with this decision which will erode substantial public investment in a quality program, as well as impact some of our most vulnerable students. In addition, it is contradictory to the current federal and provincial policy to address a looming skills gap and increase opportunities for major economic development.

In addition, there is considerable concern about the proposed amount to be cut. The province indicates that our share of overall provincial ESL is \$2.5 million which is therefore the amount to be reduced from our operating budget – we believe the number is closer to \$1.3 million. If we must find \$2.5 million the

differential of \$1.2 million will need to be found in other areas across the College in addition to our ESL programs.

This scenario is in addition to what we anticipate (though we have not received our funding letter) will already be a \$2.5 million reduction to our operating budget in order to balance the 2014-15 budget based on a 0% increase. The potential result is a total of \$5 million in budget reductions leading to significant impact to other college programs and services.

John acknowledged that it is a very difficult time. It is highly problematic, highly frustrating, and highly emotional to be in this position right now. The College has met with the Deputy Minster regarding this decision and shared our concerns. The College's intent is to make sure the government understands the impacts of the cuts. Questions and discussion followed. Discussions included, but was not limited to:

- Why the government targeted the ESL programs? Result of a shift in the funding agreement between the Federal and Provincial government, and who they believe should be delivering these programs.
- This doesn't impact our ability to serve our International Students, however, the effects to the ELD department, and our programming depth and breadth may result as we shift our programming away from domestic students.
- All the colleges will struggle with this and they are all handling differently.
- Can our community and/or employers who hire these grads help advocate for this programming? Yes, we have prepared a briefing to distribute to them.
- Our current funding for our programming ends March 31, 2014. Jan Mar 31 will be business as usual. After that is somewhat unknown at this time.
- Transition plan for students caught in this? In a worst case scenario we may need to do some extensive messaging, meet with students, etc. as we may be out of the domestic business on April 1. We don't have the resources to backfill or carry through past that date.
- We could deliver on a cost-recovery basis, but it would be cost-prohibitive to do so.
- The budget cut is consistent across the post-secondary system.
- The numbers feel misleading as the result will be an additional 1.2 million cut to general programming. Yes, hat is understandable, but this is how the government is documenting the cut and presenting to us.

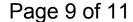

### B. Governance and Standards Issues Arising from ICC Review of Curriculum

#### **Pre-requisites**

Currently the college provides students with a lengthy list of courses and course alternates by which they can qualify to enroll in college courses and programs. The two most common of these are English and Math.

A recent English Department curriculum submission seeks to create further flexibility in how a student can meet the prerequisites for 100-level English courses. Prospective learners are required to submit proof of successful completion of a "composition/writing "course and a "literature" course from two lengthy lists created by the English department. The objective is to create flexibility; the prospective learner can meet the English pre-requisites with proof of successful completion of a course from each list.

In our efforts to be as flexible as possible, we have constructed complicated charts (English Roadmap) listing high school, School of Access, and college equivalencies. In some instances, a "C" is needed; in other instances another letter grade may be accepted.

In the case of English, there are multiple ways in which a prospective learner can meet the prerequisites for 100 level English courses. For example, in the case of English 151, a student can submit proof of any of the following:

**Prerequisites:** "C+" in English 12, or EFP 12; **or** "C" in ENGL 103 and ENGL 104; or ENGL 103 and ENGL 106; or ENGL 092 and ENGL 094; or ENGL 092 and ENGL 096; or ENGL 142; or ELD 092 and ELD 094; or ELD 097; **or** "B" in ENGL 170; **or** assessment

To complicate matters, the college has no shelf life policy on the courses used for pre-requisites resulting in the listing of additional courses that we no longer offer, but we still allow students to use for pre-requisites purposes.

There is also educational and institutional research that raises significant questions about the relationship of a pre-requisite to student success in the course or program begging the larger question of why and how requisites should be used.

#### Given this:

How should/could the college simplify the ways in which students meet pre-requisites for program admission or for course registration?

How should/could the college simplify the ways it communicates pre-requisites?

What are our beliefs about pre-requisites and their use as program or course admission requirements?

What are our beliefs about student success? What are our beliefs about the right to fail?

#### Current Requisite Definitions:

- Pre-Requisite: A requirement that must be met before entry into a course.
- Co-Requisite: A course that must be taken at the same time as another course.
- Pre/Co-Requisite: A course that must be taken at the same time or before a course.
