#### Memorandum of Understanding on Academic Cooperation Between Camosun College and Vel Tech University

#### VEL TECH UNIVERSITY, CHENNAI, INDIA

Vel Tech University, a teaching-research University with UGC recognition, was founded about two decades ago by Dr.R.Rangarajan and Dr.Sugunthala Rangarajan with the objective of providing quality education imbibed with values. By virtue of intense industry interaction, employing a multidisciplinary approach and institutional outreach, Vel Tech University carved a niche for itself with undergraduate, postgraduate and doctorate programs; these encompass engineering, science and management streams. Spread over multiple campuses in Chennai, India, Vel Tech University houses more than 18,000 students from several states across India. The hallmark of the University is collaboration with international industries and Universities, working towards notable outcomes in collaborative projects, student exchanges and joint programs. Vel Tech University is keen to initiate programs by developing partnerships with Canadian institutions' academic programs.

This MEMORANDUM OF UNDERSTANDING (MOU) is designed to foster a friendly relationship through the mutual cooperation of academic programs between **Camosun College** and **Vel Tech University**, hereinafter jointly referred as "The Parties". No financial obligations are to be assumed under this agreement.

The Parties have reached agreement on the following areas of cooperation, subject to mutual consent and the availability of sufficient funding:

The terms of such mutual assistance and funding for any specific program and activity shall be jointly discussed and agreed upon in writing by both parties, prior to the initiation of any specific program. Each institution will designate an individual to coordinate this program and any endeavors that may derive from it. For this purpose, Vel Tech University has designated Mr. K.V.D. Kishore Kumar, Vice President, Vel Tech University, and Camosun College has designated Mr. Geoff Wilmshurst, Vice president for Partnerships, Camosun College.

No amendment, consent, or waiver of the terms of this MOU shall bind either party unless in writing and signed by all parties. Any such amendment, consent, or waiver shall only be effective for a specifically stated occurrence or for a specified given purpose. The parties of this MOU, will be acknowledged by the signatures of their authorized representatives below, who having read and understood this MOU have agreed to be bound by its terms and conditions.

This MOU shall commence from the date of most recent signature and be in effect for five (5) years, at which time it shall be reviewed for a possible extension. Either party may terminate this MOU by means of written notification and the signature of the appropriate official of the institution initiating the notice. However, such notification must be received by the other party at least six (6) months prior to the effective date of termination.

#### MEMORANDUM OF UNDERSTANDING FOR ACADEMIC COOPERATION

#### UNIVERSITY OF HAWAII-LEEWARD COMMUNITY COLLEGE Pearl City, Hawaii, USA

Recognizing the mutual benefits of collaborative activities in promoting international understanding, University of Hawaii-Leeward Community College and Camosun College agree to explore the feasibility of establishing frameworks and cooperative activities in educational endeavors. Such cooperation may include but is not limited to the following:

- 1. Exchange of scholarly ideas, information, and materials.
- 2. Consultation between individual faculty, academic departments and research centers to explore activities of mutual interest.
- 3. Exchange of faculty for capacity building, lectures, and joint research activities.
- 4. Exploration of the feasibility of working together on joint projects including, but not limited to:
  - a.) academic programs
  - b.) training programs
  - c.) study abroad and exchange programs
- 5. Investigation of external funding sources for projects deemed to be mutually beneficial to both institutions.

The specific terms, expenses, and other matters arising related to the implementation of any aspects of this agreement shall be discussed in detail by the parties concerned for each case. Any commitment of resources, financial or otherwise, for cooperative activities shall be made in a supplemental agreement for that specific purpose entered into at a subsequent date and approved by the official authority of each institution.

Both Camosun College and University of Hawaii – Leeward Community College will nominate one individual from their institution as its primary representative in charge of cooperative programs. Individual projects implemented under this Memorandum of Understanding will be jointly planned and supervised by the nominees of both parties.

This Memorandum of Understanding will be effective for a period of five years from the date of signing and is subject to change, renewal, and termination by mutual consent. Termination may be made by either party, giving the other party three months notice in writing. The parties further agree to consult periodically concerning the status of the above mentioned activities and other relevant matters of mutual interest.






# Sexual Violence and Misconduct Policy College Approach
