In depth study of accounting principles, cash, receivables, inventories, capital assets, current and long-term liabilities and investments and shareholders equity. Completion of a computerized bookkeeping practice set.

COURSE LEARNING OUTCOMES / OBJECTIVES

General: The course includes the preparation of cash flow statements and analysis of financial statements for sole proprietorships, partnerships and corporations. The course also covers an in-depth study of accounting principles, cash, receivables, inventories, capital assets, current and long-term liabilities, investments, and shareholders' equity. Students will complete a computerized deliverable in Excel.

After successful completion of Acct 111, students will be able:

- Prepare and analyze financial statements including cash flow statements for sole proprietorships, partnerships and corporations.
- Account for inventory transactions, using FIFO, and Weighted Average cost flow assumptions.
- Account for shareholder's equity and share transactions.
- Calculate Earnings per Share.
- Account for long-term liability transactions, using both the straight-line and the effective interest method to calculate interest expense.
- Account for basic short-term, and long-term investment transactions.

The examinations are supervised with examination protocols which will need to be assessed prior to the examination.
