## Exams:

The midterms (25%) and final exam (35%) are both in-person at Camosun College Interurban Campus.

The midterm is approximately two (2) hours in length and the final exam is three (3) hours. The only material allowed in an exam is a calculator, pen or pencil, highlighter and eraser. All quizzes and exams are closed book, with the following exceptions; An information sheet will be provided by the instructor (see D2L for a copy of the sheet to be provided). In addition, students may bring into the examinations "personally prepared notes" in the following format. Notes may be handwritten on a standard letter sized sheet (8.5 x 11 inches). No numerical examples may be included in the notes. Any violation of these requirements will result in confiscation of the notes as well as potential academic consequences.

• Final ONE double-sided sheet.

These note sheets must be handed in with your exam and will be retained by Camosun College. Please make a copy for yourself if you want to use the notes later in the course.

If any resources are perceived as needed for the quizzes, you will be provided with the relevant information for that quiz.

Show all calculations. There are no marks providing only the correct answer. Marks are only awarded for fully supported/explained responses. This includes responses to questions without calculations. This policy applies to homework/assignments, quizzes, exams and any other submissions.
