## COURSE SCHEDULE, TOPICS, AND ASSOCIATED PREPARATION / ACTIVITY / EVALUATION

WEEK or DATE RANGE	ACTIVITY or TOPIC
WEEKS 1-4	<p>In this course we will be looking at the diversity of populations, cultures, environments, and beliefs associated with adventure education. This will involve three main things: how adventure education is practised and for what purposes; how adventure education has evolved in particular ways and for particular purposes; how adventure education might be ignoring or have blind spots with regards to issues such as gender, destructive consumerism, colonialism, curricular conservatism. We will use these three areas of investigation to develop our ideas about how we might wish to evolve our practice as outdoor adventure educators. The course is divided into three main sections.</p> <ul style="list-style-type: none"><li>• In weeks 1-4 we will begin by looking at ourselves and thinking about where we have come from and what might influence our outlook on adventure education.</li></ul>
WEEKS 5-11	<p>In weeks 5-11 we will look at a variety of ways of thinking about and doing adventure education by examining how it is done in different places around the world.</p> <ul style="list-style-type: none"><li>• In weeks 5-8 you will work in pairs to research a region/country and then share your findings with the whole group.</li><li>• In weeks 9-11 you will focus in on one or two particular issues that have been highlighted during the investigation phase.</li></ul>
WEEKS 12-14	<ul style="list-style-type: none"><li>• In weeks 12-14 you will be taking what you have learned and thinking about how you might use that knowledge in your own context as an adventure educator</li></ul>
