- Identify and articulate the breadth of adventure programming internationally.
- Articulate and apply theoretical and conceptual knowledge in the design and delivery of adventure programs.
- Identify and articulate current standards & best-practices in adventure program design.
- Articulate the range of adventure programming including depth of intervention, sector-specific, scope
  of practice and risk management.
- Describe assessment, evaluation, and research processes in adventure education.

# COURSE SCHEDULE, TOPICS, AND ASSOCIATED PREPARATION / ACTIVITY / EVALUATION

The following schedule and course components are subject to change with reasonable advance notice, as deemed appropriate by the instructor.

WEEK or DATE RANGE	ACTIVITY or TOPIC	
WEEKS 1-4	In the opening weeks of the course we will build on concepts and experience from the summer term to consider what might be the foundational pillars of an adventure education program or curriculum (e.g. experiential education, student-centredness, uncertainty, authenticity, etc) and how they can be implemented in your particular working context. This will then be used to create a new, or revise an existing, short lesson/session relevant to your professional field.	
WEEKS 5-10	In this unit we will build on the principles discussed in weeks 1-4 considering both the opportunities they open up and the challenges they may face. You will develop a 1-2 day experience/program and in doing so engage more deeply with institutional and social policies and practices related to outdoor-and adventure-based programming. Opportunities and constraints will come to light through this exploration. Engaging with these opportunities and constraints will give direction, scale, and scope to your programming – helping you understand what is currently possible (current space) and where you might be able to expand into (adjacent possible space) with your AE program/curriculum design ideas.	
WEEKS 11-14	In the final weeks you will bring together your developing ideas regarding the philosophy and methodology of adventure education, and the possibilities for its application in your individual context by engaging with a longer term – a semester or a year – program/curriculum design.  The central concept in this longer-term design planning will be the intent to have continuity, connection, and a rhythm to the learning over an extended period of time. Zooming out to a larger scale perspective provides the opportunity to use a deep level of understanding of outdoor adventure education to advocate for its application in your professional context.
