## COURSE SCHEDULE, TOPICS, AND ASSOCIATED PREPARATION / ACTIVITY / EVALUATION

The following schedule and course components are subject to change with reasonable advance notice, as deemed appropriate by the instructor.

WEEK or DATE RANGE	ACTIVITY or TOPIC	
WEEKS 1-4	In this unit we will draw on concepts and experience from previous courses to consider what might be the foundational pillars of an adventure education program or curriculum (e.g. experiential education, student-centredness, uncertainty, authenticity, etc) and how they might be manifest in your particular working context. This will then be used to create a new, or revise an existing, short activity/lesson.	
WEEKS 5-11	In this unit we will build on the principles discussed in weeks 1-4 and their applications. We will develop the short AE session with your students into a 1-2 day field trip.  An additional purpose of this second activity is to engage more deeply with institutional and social policies and practices around outdoor-and adventure-based programming. Opportunities and constraints will come to light through this exploration. Engaging with these opportunities and constraints will give direction, scale, and scope to our programming —helping each of us better understand what is currently possible (current space) and where we might go (adjacent possible space) with AE programming.	
WEEKS 12-14	In these final weeks, we bring the underpinning philosophy and methodology of adventure education and the possibilities for its application in our individual contexts together as we look at longer term – a semester or a year – program/curriculum design.  The central concept in this longer term design planning will be the notion of "tension". Tension in this context refers to the opportunities and challenges that exist within the various institutional and social elements, the educational ideas and the space for their application, and the opportunities and challenges between your understanding of AE and the program you have devised.
