Facilitation knowledge and skills are central to creating and leading successful learning experiences. Students are challenged to practice and assess their capacity to lead others in experiential learning activities. The course includes an examination of learning and change theories and the dimensions of transformational learning (psychological, emotional and behavioural) as they relate to adventure program design, facilitation styles and practices.

- Interpret and utilize conceptual knowledge of the experiential learning process.
- Demonstrate the technical skills of developing and leading meaningful intentionally designed experiential activities.
- Use their leadership capacity to demonstrate facilitation models, styles and approaches in adventure programming.
- Articulate change theories and integrate processes for participant meaning-making within an ethical and professional practice.
- Identify areas for further personal development as a facilitator.
