# COURSE LEARNING OUTCOMES / OBJECTIVES

Water-based activities are common in adventure education and require knowledge of industry standards and skills to deliver safely and effectively. Students will develop practical skills and knowledge for waterbased travel and coastal living. The course will include an overview of equipment options, logistics, participant assessment and program design options for a variety of populations. Leadership styles and skills will be identified, assessed and critically reflected upon relative to a variety of professional career options.

Students must be comfortable in water but do not require swimming proficiency.

• Demonstrate technical skills for managing group safety while using paddlecraft.

- Demonstrate knowledge and skills to plan, navigate, and travel through a spectrum of environmental conditions.
- Design theoretically supported adventure programs to accommodate varying levels of challenge, ability and interest.
- Practice resilience in managing adverse situations and conditions.
- Set realistic but challenging goals for their ongoing development as an outdoor leader.
- Demonstrate professional behaviours in leading others toward their objectives.
