Course Description:

Students engage in learning activities illustrating the legal responsibilities of allied health practitioners to promote ethical, compassionate, and caring service to the public. Students use online discussions and projects to apply legal and ethical workplace standards using case study scenarios. To further their understanding, students examine how federal and provincial legislation and regulations affect the practice of analytical, diagnostic, and therapeutic medicine.

Course Guidelines & Expectations

Assignments:

- Detailed information regarding assignments will be available on D2L via course content and on the specific assignment or discussion dropbox/location
- Complete all assignments on time and submit on the designated due dates (**review Calendar on the syllabus, D2L, and specific dates on Assignments/Discussions**). It is the student's responsibility to maintain awareness of due dates.
- Unless otherwise directed by individual course outlines or assignment descriptions, assignments must be: word processed, double spaced, font meeting APA 7th edition guidelines, with a title page and reference list in APA 7th edition format.
- The use of AI generated tools is permitted ONLY for brainstorming and organizing your ideas. Its use will not be tolerated when passed off as original writings for class assignments. Any assignment that can be proven to have used AI tools in an unauthorized way will be treated as plagiarism and given a zero. - In exceptional circumstances, students may request an extension; however, that extension must be arranged with the instructor at least 24 hours before the due date. Students who have not pre-arranged an extension will have 10% of the total possible mark deducted per day from late assignments, and will not be accepted after 7 days post due date.
- Incomplete assignments will not be accepted
- Unless otherwise stated, all assignments will be submitted via D2L
- In emergency circumstances, a student may arrange to take an assessment before or after the scheduled time if the student would otherwise be unable to complete the program or course.
- Exceptions due to emergency circumstances, such as health problems, or unavoidable family crises, require the approval of the instructor. Holidays or scheduled flights are not considered to be emergencies. The student may be required to provide verification of the emergency circumstance.

Suggested Study Time/Study Habits:

- It is expected students will take accountability in their learning by maintaining awareness of all availability dates of content, due dates of assignments/discussions, and course updates via the D2L Newsfeed
- **Students are expected to read/interact/reflect on all provided course content unless noted as optional. All content in the course which is required is potentially assessable material**
- Successful students will probably spend 2 - 4 hours outside of class per week studying the content for this course to achieve full marks. This is in addition to the time it takes to navigate and participate in the online content and discussions.
- The instructor will be available by email, through discussions and by appointment for students needing additional support mastering the course content
- Map out a homework schedule; include time for reading and discussion
- Study groups are a highly effective way of learning for many students

Attendance

- As an exclusively online course, there are no synchronous sessions students must attend.

Student Assessment

- Students must achieve a minimum of 65% in order to pass this course and use it as a prerequisite. Detailed information regarding assignments will be available on D2L. Complete all assignments on time and submit by the designated due dates. All assignments will be submitted via D2L.
