CALENDAR DESCRIPTION

Indigenous and Non-Indigenous students will be introduced to contemporary studio art through the perspectives and practical experiences of Indigenous techniques and ways of knowing. Students will use a variety of media, processes, and theories to discover their own interculturally aware stories and ways of making. Students may use this course as preparation for visual arts studies, a university transfer elective, or an experience to increase visual literacy/appreciation of Indigenous arts.

1. Describe and apply conceptual and practical knowledge of a range of Indigenous artistic practices.

2. Describe and apply conceptual and practical knowledge of historical and contemporary approaches to studio arts.

- 3. Describe historical and cultural issues influencing Indigenous artistic practices.
- 4. Describe the diversity, history and contemporary context of Indigenous artistic practices.
- 5. Develop an independent project, which amalgamates the course content.
- 6. Discuss and critique artworks of practicing Indigenous artists and fellow students.

REQUIRED MATERIALS & RECOMMENDED PREPARATION / INFORMATION

I will post a any additional required readings and documents online, either as external links or as pdf files on the D2L site for the course. You can read these materials online, but they will be required, unless specifically marked as optional. All readings should be done by the beginning of that week.

Required Supplies:

- Sketchbook 8x10, or 10x12 your choice. Suitable for watercolor or felt pens.

• tray for mixing paint(Can use recycled Styrofoam meat trays, wax paper taped down) or if you can afford it, a covered tray, with stay wet foam is great but not required)

- Gum Eraser
- Ink pens (optional)
- We will use acrylic with a retarder instead of printer ink
- Brayer 4 inch
- Small piece of glass for ink rolling 8x10 approximately
- Ruler
- Tracing Paper(optional), palette paper optional

• Lino cut block 4"x6" x 2 (Opus)*Note if you want to carve on wood instead, buy a piece of wood to carve and wood carving tools

- One larger lino cut or wood block 10x12 approximately
- Linocut carving set
- 1 black Poster board
- 6-5x7 mat frames black

- masking tape, double sided tape
- scissors
- water container for brushes and a rag or paper towel
- Printmaking paper x 12 pieces. We can practise on computer printer paper, I will supply.
- We will make a small drum. Cost covered by College.

• Acrylic paint, tube and liquid (not fluid) in basic colours plus back and white, brushes and 2 canvas or wood supports no smaller than 18x24 or if you prefer to work on paper with water colour paint, then ensure the paper is heavy enough weight for the medium you have chosen. Suggested brushes should be for acrylic paint, one large flat size 12, one round 2, 6,4, 2,1 Filbert size 6, one liner brush. One larger 2' house painting brush is useful. We will **not** be using oils or **sprays** due to sensitivity. If you have art supplies already and want to use what you have that is fine as long as they are acrylic.

COURSE GUIDELINES & EXPECTATIONS

This is a studio-based course, taught from an Indigenous perspective, by a practising Métis artist. Students will, through lecture, reading and looking at Indigenous art and artists, develop an understanding of the three Federally recognized Indigenous peoples in Canada, and their diversity. Students will understand some of the history of oppression and how that has impacted Indigenous culture and artistic practise. They will develop an understanding of some Indigenous artistic process, through a hands-on, studio approach. By completion of Art 106, students will develop an understanding of the diverse styles of each major Indigenous group and will be able to apply that knowledge and way of knowing, to their own diverse cultures and creative practise.

Because this is a studio course, students will arrive, ready to work, clean up after themselves and will contribute to a safe and supportive learning environment. Class discussion, critique and participation is required to successfully complete this course.

Participation/Professionalism

A fundamental belief that all Indigenous people share, is that of **respect**. Respect for the planet, for yourself, your family and your community. We believe that **all things** are **connected** and therefore **worthy of respect and honor**.

We will show one another **respect** in this class, by being on time, and arriving prepared to work. If you cannot come, due to illness, you will be required to complete all designated assignments, and you will contact me to let me know. Participating in class discussion, critique and presentation is paramount, as we learn as much from each other as we do from assignments. **Your presence matters!**

Due Dates and Late Assignments

All assignments are due, on listed dates. If for some reason, you cannot submit assignments on time, please contact me so we can find a solution that works.

Late assignments will not be accepted after 10 days unless your reason is legitimately approved by me. If work is not completed by the week following, the grade will diminish by 50% and will not be accepted after two weeks or class dates have passed.
