Through a series of lectures, discussion groups, and research assignments, students will explore and interpret contemporary visual art in relation to art theory. This class will assist artists to better situate their art practice by broadening their theoretical and cultural awareness. Students will learn how to locate their work and ideas through informed understanding, critical awareness, and an open exchange of ideas.

- 1. Identify and distinguish between the fundamental theoretical frameworks that have shaped contemporary art practice and theory from the perspective of a practicing visual artist.
- 2. Examine art, art media and artists via ideas and concepts formed through major philosophical, aesthetic, political, psychoanalytic, gender and social systems.
- 3. Generate well-informed arguments that reject, build from, or support important theoretical issues as they relate to art critique.

- 4. Research, write, and present one's interpretation or evaluation of contemporary art issues through one or more theoretical approaches.
- 5. Examine and relate one's studio practice in relation to art theory.
- 6. Debate and formulate theoretical discussions in small and large self-led groups.

EVALUATION OF LEARNING

1. INTERSECTIONS PROJECT

The Intersections Project involves selecting a theme of interest to research through a range of methods including arts-based research and traditional text-based research (publications/articles). From the research, students will develop a proposal, a presentation, and paper. The arts-based research for the project focuses on expanding perspectives of the theme to aid in developing a sub-theme and depth of understanding. Traditional text-based research includes exploring two artists (one contemporary) whose work intersects with the theme in some notable way. Please see the Intersections Project Brief for more information on themes, steps, requirements, and assessment criteria.

2. VISUAL JOURNAL

DUE: October 27 (9:30 AM) **ASSESSMENT WEIGHT:** 30%

Visual Journals are like a sketchbook that includes reflective, critical, and creative written and visual responses to assigned topics. Two Visual Journal entries will be assigned each week. These entries will allow for independent interpretation and exploration. Visual Journal entries will be shared with the whole class each week to support with collaborative development of creative and critical thinking. Entries completed on a class-to-class basis will be assessed for participation grades. Visual journals will be handed in for final graded assessments on the date listed above. 3. **ACTIVE PARTICIPATION** (20%)

Participation is assessed on a sliding scale based on quality of work and contributions. For example: 1/5 = 20%, 2/5 = 40%, 3/5 = 60%, 3.5/5 = 70%, 4/5 = 80%, 4.5/5 = 90%, etc.

COURSE GUIDELINES & EXPECTATIONS

ATTENDANCE

Due to the experiential nature of the course, regular attendance is required. As a professional courtesy, students must **independently** inform the instructor by email <u>prior to class</u> about known absences and must plan ahead and submit work <u>prior to the deadline</u> for planned absences. More than three <u>unexcused*</u> absences may result in a student not passing the course. <u>Informed absences and those given prior permission due to the unavoidable nature of the absence</u> will be <u>excused</u>. Three late arrivals or early departures to/from class will be considered the equivalent of one absence. Prompt attendance is a professional responsibility and a requirement of the course.

If a student must miss a class due to an unavoidable circumstance, it is the student's responsibility to request missed materials from the instructor, through email, in a timely manner. Upon a student's request, the instructor will provide students with handouts, deadlines, and any resources available online. Video or audio recordings will not be taken of the class (the exception being for an individual student to support a specific

ongoing accommodation). Because the course is delivered as a F2F Seminar (involving discussion), missing class will ultimately mean missing some content covered through discussions.

EXTENSION / LATE POLICY

Extensions on assignments may be granted by consultations with the instructor <u>prior</u> to the due date. Please email your instructor directly in advance of the deadline to request an extension. Extensions will only be granted prior to assignment deadlines and must be requested through <u>student-initiated</u> consultation/negotiation with their instructor (this includes all forms of accommodation). Late assignments (without arrangements made prior to the deadline) will not receive participation marks for that assignment and for graded assignments will be deducted 2% per <u>calendar day</u>. These submissions will NOT be accepted seven days after the due date.
