#### COURSE LEARNING OUTCOMES / OBJECTIVES

At the completion of this course, students will be able to:

- Identify common life-threatening conditions.
- Identify and evaluate head trauma symptoms and provide appropriate follow-up care for the individual based on current protocols.
- Explain emergency conditions that warrant immediate action by a medical team.
- Identify, assess, and manage facial, abdominal and thorax injuries.
- Identify environmental related injuries and diseases and apply the appropriate intervention.
- Access and maintain client airway in emergency situations utilizing oral-pharyngeal airways, baseline vital monitoring, and pocket resuscitation masks.
- Administer oxygen to individuals in a safe and effective manner utilizing appropriate delivery devices.
- Prepare the head/spine injured individual for emergency transport utilizing proper spinal board immobilization and removal techniques.
- Identify, assess, and immobilize extremity injuries including fractures, dislocations, and subluxations.
- Demonstrate proper professional conduct when interfacing with a medical team and communicating with the injured individual.

# Class / Lab Participation & Expectations of Conduct

Students participate in role-playing activities to practice skills on each other. Please be aware that learning what the human body feels like in a healthy condition is important when it comes to recognizing unhealthy or injured states. In the course of learning to do assessments, students will need to be palpating other students on a regular basis. Students must refrain from any inappropriate touching. Students with concerns are to speak to the instructor prior to the beginning of the course or as it arises during the semester. There can be no exception to this participation.

Students will maintain optimum levels of safe behavior (personal hygiene, decontamination of personal protective equipment, care with lifts and use of proper body mechanics, etc.) with a minimization of potential for disease transmission.

Students must come appropriately dressed to allow for hands on application / demonstration of emergency care techniques.

Low cut shirts, pants / shorts that expose underwear, and flip flop sandals are NOT acceptable dress for labs. Students should expect that any lab may be conducted outdoors, regardless of weather, to simulate real-life working conditions.

Students that do not come prepared to actively participate (appropriate dress, fanny pack, etc.) in labs may be asked to leave.

#### Attendance

Research shows a strong correlation with class attendance and academic success. Given the practical nature of this course, and the need to understand the theory utilized during the labs, attendance at lectures is strongly encouraged.

Given that completion of the skills checklist is a requirement for the Red Cross Professional Responder Certification, lab attendance will be taken.

#### For any of the below, it is required that students contact the instructor.

An excused absence includes:

- b) Bonafide intercollegiate trip with supporting documentation.
- c) Permission of instructor prior to absence.
- d) Compassionate reasons.
