- e. Describe how social networking and other Internet applications apply to business.
- f. Identify computing risks, threats, and protection strategies.
- g. Use introductory concepts of coding.

Use software up to an intermediate level for a variety of business applications including document production, spreadsheets, databases, and presentations and file management for local networked devices.
