**REQUIRED:** A recent PC (not Mac) that includes audio, reliable internet, and MS Office Suite (2019) installed. All required software is normally provided on campus in the Camosun computer labs. For home, you will need to download and install MS Office Suite (2019) by first registering for Camosun's free Office 365 for students ( <http://camosun.ca/office365> ) and then installing the downloadable versions of PowerPoint, Word, Excel, and Access. If you are using your own copy of MS Office 2019 it is the students' responsibility to ensure in advance that it includes MS Access, which is required for the database portion of this course and does not exist for Mac.
