# CALENDAR DESCRIPTION

Students study human behaviour in organizations from an individual, group or organization-wide perspective. The effects on behaviour of factors such as stress, leadership, motivation, team-based processes, conflict, structure, quality of work life and organizational culture are examined. Cases are used to develop and apply critical thinking and analytical skills.

Upon successful completion of this course, a student will be able to:

- 1. Examine key concepts, theories, and models that influence individual and workplace behaviour and performance within an organizational context.
- 2. Apply concepts of stress, motivation, decision making, power, conflict, leadership, culture, and sustainability in identifying and analyzing issues in an organizational setting.
- 3. Demonstrate knowledge of team processes and how they influence team effectiveness
  - Develop effective skills and strategies as a member of a self-directed work team
  - Recognize the importance of effective communication in teams and in organizations and explore strategies to improve communication
- 4. Describe the elements of organizational structure, evaluate departmentalization types, and discuss factors to consider when designing an organizational structure.
- 5. Apply change management strategies and theories to reducing resistance to change.

- Increase awareness of cross-cultural and ethical issues in implementing organizational change.
- 6. Apply critical thinking and analytical skills through the use of case studies in organizational behaviour.

#### USE OF GENERATIVE ARTIFICIAL INTELLIGENCE (GENAI) TOOLS

This is specifically about GenAI tools (e.g., ChatGPT, Bing Chat, etc.) but applies to using any artificial intelligence technology in this class. GenAI tools are available to students in this course. The purpose of this section is to outline the guidelines for using GenAI tools in this course and to specify the restrictions on its use.

- Students may choose to use GenAI tools to assist with understanding course concepts, summarizing lectures, or writing assistance, but the final product must be their own original work. It is essential that students recognize the importance of generating their ideas and thoughts to enhance their critical thinking, problem-solving, and decision-making skills. Therefore, the use of GenAI tools should be seen as a supportive tool, rather than a replacement for students' ideas and efforts.
- Students are responsible for understanding the limitations and potential biases of GenAI tools and for critically evaluating their output.
- Students are responsible for any output produced, and are ultimately accountable for the work they submit.
- Students must document and be transparent about their use of GenAl tools. The documentation should accompany each assignment and include what tool(s) were used, how they were used, and how the results were incorporated into the submitted work. Any content producted with the support of a GenAl tool must be cited appropriately, following APA format.
- Students are not permitted to use GenAI tools to complete quizzes or exams. Any use of GenAI tools for such purposes will be considered academic dishonesty and will result in appropriate action being taken, in line with the College's academic integrity policies.

#### Attendance and Teamwork

It is critical that students make a commitment to attend <u>ALL</u> classes to enable effective teamwork.

#### Assignments Overview

Working effectively in teams is an essential skill and a critical part of this course. There are two major assignments involving teamwork, which together are worth 35% of the final grade.

#### Team Project – Case Analysis (15%)

In teams of 4-5, students will work collaboratively to analyze current issues or events through an organizational behaviour (OB) lens. Using a real-life situation, students will apply OB concepts to identify contributing factors, and to explore how OB concepts could be applied to better understand or resolve the issues.

This project has three parts:

- 1) Team contract
- 2) Written report
- 3) Peer review

#### Team Project – Organizational Analysis (20%)

In teams of 4-5, students will analyze an existing organization integrating course concepts. As a team, students will conduct research on the organization and interview an employee at that organization in order to write a detailed analysis about the organization.

This project has four parts:

- 4) Team contract
- 5) Project proposal
- 6) Interview & analysis written report
- 7) Peer review
