## CALENDAR DESCRIPTION

---

Students will apply a number of statistical techniques used for business decision-making. They will learn to solve business problems and make related predictions using simple and multiple regressions, exponential smoothing, non-parametric statistical procedures, analysis of variance, seasonal and enumerative data, linear programming, and inventory control models.

## COURSE LEARNING OUTCOMES / OBJECTIVES

---

Upon successful completion of this course, students will be able to:

1. Utilize appropriate tools to support quantitative problem solving.
2. Apply the F-distribution and the concept of analysis of variance (ANOVA) to compare the means of multiple populations and make inferences about the relative variances of two populations.
3. Develop simple and multiple linear regression models for analyzing cross-sectional data.
4. Apply the chi-squared distribution and non-parametric methods to hypothesis testing and the analysis of ranked data.
5. Use and explain concepts related to statistical quality control.
6. Construct and use indices to compare data.
7. Choose appropriate time series methods and use them to forecast in-sample and out-of-sample data.
