Students will examine the foundations of the Canadian legal system, including Indigenous law, and apply this knowledge to a range of business environments. Learners will obtain the theoretical and applied knowledge of basic legal principles as they pertain to business practices to ensure compliance with the law and reduce legal risk.

# **EVALUATION OF LEARNING**

a) **Exams** – 60% of total course marks as follows:

Students will write two (2) exams: a midterm exam and a final exam. Both exams are, 110 minutes long, are open book\* and each is worth 30%. The midterm exam covers chapters 1-5 and the final exam covers chapters 6-11 (inclusive for both). The midterm exam is during class time on February 16. The final exam will be scheduled during the final exam period.

- \* Students are not allowed to use the Internet/smartphones during open book exams except to access the e-text. Exams are invigilated and students must write all exams on Camosun computers in a computer lab.
- b) Quizzes\*\* 20% of course marks as follows:
