CALENDAR DESCRIPTION

Students will examine the foundations of the Canadian legal system, including Indigenous law, and apply this knowledge to a range of business environments. Learners will obtain the theoretical and applied knowledge of basic legal principles as they pertain to business practices to ensure compliance with the law and reduce legal risk.

4. Use appropriate resources to manage and minimize legal risks in the business environment.
5. Apply legal analyses to fact patterns related to contracts, torts and select areas of law.

EVALUATION OF LEARNING

a) **Exams** – 70% of total course marks as follows:

Students will write two (2) exams: a midterm exam and a final exam. Both exams are open book* and each is worth 30%. The midterm exam covers chapters 1-5 and the final exam covers chapters 6-11. The final exam will be scheduled during the final exam period.

* Students are not allowed to copy and paste during open book exams. All answers must be the student's own.

b) **Quizzes and Factual Analyses and Class participation**– 30% of course marks as follows:

Students will complete up to 6 (six) quizzes. Only the four best marks will count in final grade calculation. Students will also complete 4 (four) factual analyses. The marking scheme and required format will be discussed in class. Class participation marks will be based on in class group activities.
