#### CALENDAR DESCRIPTION

This chemistry course emphasizes the chemistry of water, the detection of pollutants and water treatment. Students will study basic concepts in chemistry, gases, solubility, electrolytes, pH, pollutants and methods of detection, natural cycles of nitrogen, phosphorus and carbon as well as the role of bacteria. Applications to civil engineering are included throughout the course.

# COURSE LEARNING OUTCOMES / OBJECTIVES

Upon completion of this course a student will be able to:

- 1. Apply the safety procedures applicable to a chemistry laboratory.
- 2. Apply the basic terminology and tools used in chemistry including: components of the periodic table, units, the mole concept, balancing of equations, chemical nomenclature and chemical bonding.
- 3. Use the gas laws to calculate changes in a gas temperature, pressure and volume and apply the concepts of vapour pressure and partial pressure.
- 4. Describe the processes of dissolution and precipitation and apply equations of solubility; differentiate between a solution and a suspension.
- 5. Describe common contaminants in natural water supplies and the methods used for measuring them.
- 6. Define LD50 and describe simple concepts of toxicology.
- 7. Describe the natural cycles of nitrogen, phosphorus and carbon.
- 8. Identify various types of bacteria and their metabolism.
- 9. Describe bacterial growth and the bacterial growth curve.
- 10. Apply the fundamentals of chemistry to such applications as: corrosion and cathodic protection; hydration of Portland cement; polymers and plastics.

#### COURSE GUIDELINES & EXPECTATIONS

There is an expectation that students complete FIVE laboratory experiments, along with the associated assignments. In the event that you miss a laboratory session, your options include; completing the experiment with the following group (Only Group A students have this option), perform the experiment 6 make-up experiment in Week 14, or request data in order to complete the assignment.

Post-Lab assignments will be submitted on, or before your next laboratory class, unless you have prior accommodation through CAL, or have requested an extension due to extenuating circumstances. You must hand in your own assignment and pre-Lab assignment, regardless of whether you have worked with a partner and obtained the same data.

<sup>\*</sup>Experiment 6 is an optional experiment that can be used to replace a lower experiment score, or make up for a missed experiment.

Students must write each test during the time scheduled in the course outline, and submit required assignments by the specified deadline. On a case-by-case basis, and at the instructor's discretion, a student experiencing a personal emergency or an uncontrollable extenuating circumstance (as outlined in the Academic Concessions Policy) may be offered a concession for missed tests/quizzes/reports, if possible and appropriate.

If it is advantageous to the student the theory mark will be solely derived from the final examination, or a combination of midterms and the final. Students who have completed <u>all three term tests</u> with a minimum of a 73 % (B) average have the option to be graded out with their existing grade in lieu of taking the final exam if they so wish.
