COURSE LEARNING OUTCOMES / OBJECTIVES

As students are taught principles of structured programming, they will see concepts illustrated with examples and do problems from science and engineering disciplines. Topics include: elementary features of the programming language used, such as data types and structures, control flow, input/output, functions; the programming environment; problem solving process.

Upon completion of the course, students will be able to:

- 1. prepare an algorithm for solving a problem;
- 2. use functions and parameters appropriately and correctly;
- 3. define, reference and modify one-dimensional arrays correctly;
- 4. access, define and modify character string arrays correctly;
- 5. read, write and calculate with integer and real data items;
- 6. use functions from selected libraries;
- 7. use effectively the computer environment for program development;
- 8. write program documentation appropriately;
- 9. write a 200-line program of some logical complexity involving input and output, and
- using a disciplined style; and
- 10. test and debug code.
