- tell stories of complexity, hope and possibility, not stories of deficiency. This is a place of healing and of learning. This holds true for people of all races, genders, and abilities.
- Peer edits (and indeed my edits) are to be given in the spirit of encouraging classmates and helping them believe in themselves as writers. We aim to help each other make our stories the strongest they can be by recognizing that we all have talents, and that writing is hard work.
- In this class, we start with the belief that writing is important, and that creativity is something to be celebrated and nourished. To that end, we will have many opportunities to share writing out loud with the class.
- Because the goal of creative writing classes is to enhance students' ability to write prose, develop stories, and learn techniques for creating strong characters and settings, all forms of generative artificial intelligence (ChatGPT, Quillbot, etc...) are counter to your own learning and self-interest in our context. For this reason, the use of GenAI tools is prohibited for all assignments. Please note: we may decide to play about with a GenAI tool in class. That is not to be understood as permission to use it in your marked assignments.
