COURSE GUIDELINES & EXPECTATIONS

1. Late Penalty

All late written work will be penalized by 10% per day unless an extension is legitimately warranted AND approved by the course instructor in advance of the assignment due date.

2. Written Assignment Requirements

All written assignments must be double spaced, 1-inch margins, etc. meeting the basic requirements as set out in APA style. All work must be your own original work.

Assignments will be discussed and explained in class and posted to D2L. Due dates will be provided for each assignment.

Participation activities (20%) will occur during class time. There will be 4 in-class activities, each valued at 5%. These will occur on random dates. If you are not in class on the day of an in-class participation activity you forfeit that portion of your grade however students will be provided an opportunity at the end of the semester to make up for one missed in-class assignment.

3. Plagiarism, Cheating and Academic Dishonesty

If the course instructor can document plagiarism, cheating and/or academic dishonesty, the penalty will be an automatic "zero" on the assignment in question. Further disciplinary action may be taken as per Camosun College policy.
