CALENDAR DESCRIPTION

This course provides an introduction to the roles and behaviour of effective criminal justice practitioners. Emphasis will be on the examination of self as practitioner, ethical practice, effective working relationships within justice-related systems, and developing a personal plan for work-life balance.

COURSE GUIDELINES & EXPECTATIONS

Basis of Student Evaluation

Values Essay 10% - Due October 3rd before 12:00 am.

This is a reflective writing assignment. You will need to spend some time thinking and possibly talking with family members or those close to you before you start to write. Assignment details will be discussed in our first class and provided on D2L.

Leadership Essay 20% - Due October 31st before 12:00 am.

Based on either "Indian Ernie" or "The Tattooist of Auschwitz" you will synthesis the course material and your personal experiences with the reflections provided by each author. Assignment details will be discussed in our first class and provided on D2L.

Mid-term Exam 20% - November 14th @ 4:00 p.m.

Students will write an in-class mid-term exam based on the material covered to date including lectures, class discussions, videos, and readings.

Group Interview Project 20% - November 18th - December 5th.

Working in groups of three, you will organize, prepare, and conduct an interview with a professional working within the field of Criminal Justice. This interview will take place in our classroom and will focus on the professional practice of the interviewee as it relates to the concepts we have studied in this course. Details will be discussed in class and posted to D2L.

Reflective Journal Assignment 20% - December 2nd before 5:00 p.m.

Each week you will write a short personal reflection based on the class. The assignment will also record your work/life balance and resiliency efforts for the week. Details will be discussed in class and provided on D2L.

Preparation and participation in class 10% - December 5th before 5:00 p.m.

Regular attendance and active participation are required. It is expected that you will join the class on time, be attentive, non-disruptive, constructive and respectful. You will be required to submit a one-to-two-page summary of what you feel your mark should be out of 10 the last day of class for 10% of your participation grade. This is to include attendance, participation in class, group participation and keeping current and up to date on all readings and assignments. You will be expected to answer a series of questions on your participation and upload it to D2L.

You are expected to complete the assigned readings before coming to class, except when advised otherwise. This often becomes increasingly more difficult as the semester moves along and as the completion of assignments and preparation for exams takes a great deal of your time. I would strongly recommend that you use some type of day book where you can keep track of each week's reading, exams and other expectations being placed on you.

Written Assignment Requirements

All assignments must be uploaded to D2L prior to the date and time indicated. If you anticipate the timely submission of work will be problematic, see the course instructor in advance of the due date. All written assignments must be type-written, single sided, double spaced, and formatted in APA style.
