COURSE GUIDELINES & EXPECTATIONS

All assignments must be completed to meet requirements of this course.

Review posts on Monday on D2L to ensure you are prepared for class each Friday. Additional readings, slides and other information will be provided.

Participation (10%)

You are expected to attend each class and be prepared to contribute to discussions on the readings assigned for each week. We will explore information throughout the course that you will be expected demonstrate a working knowledge of during discussions, role plays and group work. You will provide a self-assessment for participation at the end of the course for my review and consideration of grade assignment for participation. The following information should be included in your participation assessment:

Students can demonstrate constructive participation in a variety of ways:

- physical attendance at classes
- verbal involvement in class and online discussions
- active participation in role-plays or other group exercises
- initiating discussion or bringing in information from assigned readings, other readings, and/or experiences
- demonstration of effective conflict resolution skills with colleagues
- timely submission of assignments

Written Assignment Requirements

All assignments must be handed in using the Drop box submission provided or physically handing in your journals. If you anticipate the timely submission of work will be problematic, please let me know in advance of the due date. Unless otherwise directed, all written assignments must be type-written, single sided, double spaced and formatted in APA style. Journals can be written in notebooks.

Reflective Journal Assignment and Discussion Questions (20%) Due in Week 9

From Week1 to end of Week 7 you will write a short personal reflection based on the class, readings, and material discussed in class. Four reflective questions each week to include in your journal are:

1. Three key points or insights from class –you can include more than 3

- 2. Two questions or wonderings you have based on class lessons and activities and readings
- 3. One personal reflection and example
- 4. A principle or practice you plan to use, how and why?

In addition, each week several discussion questions will also be posted on D2L for you to include in your journal writing. This assignment is not in APA format and is written in 1st person. Journals can be handwritten in notebooks or typed in a word document.

Mid-term Exam 20% - Week 8

Students will write an in-class mid-term exam based on the material covered up to and including week 7 including lectures, class discussions, videos, and readings.

Role Play and Assessment Assignment 15% Week 9 and Summary due Week 10

You will be assigned a small group to do several role play scenarios Role play scenarios will be provided to each group. Group members will do the role plays with observers completing assessment template forms for each role in the role play. For the assignment, you will need to provide a written analysis of the role-play and the assessment form of your participation in the role play including the following areas:

- 1. Introduction—Briefly describe the context of the role-play: What was the conflict about? In your role what were you trying to address and outcome you were looking to achieve.
- 2. Preparation—Describe the steps that you and the other parties took to prepare for this exercise, for example, reflection or mental preparation; use of instruments to aid in preparation; theory and approaches from your readings that you planned to apply; steps taken to set up prepared.
- 3. Overview of the Intervention—Briefly describe the overall process of the CR interaction. Write this narrative in either third person or first person, depending on which you believe
- 4. Critique—Provide an overall critique analysis of what worked well, what did not work well, and why.
- 5. Conclusion—Describe any follow-up that you would suggest for dealing with the conflict in the role play. What was your key learning from this exercise? How did the role-play and analysis may have added to your understanding of what you have read and discussed in class? Was there anything that you learned that went beyond what was covered in class and in your readings?

Additional information will be provided in class and on D2L. Your assignment is completed as group for the role play and assessment forms, but the written submission is done independently. Role plays will be conducted in class and the assignment is due the following week in the drop box March 12, 2024.

Restorative Justice Case Study Group Presentation (15%) Week 11

Each group will be assigned a case study to review and present to the class, comparing a restorative approach versus traditional justice practice. The presentation will be 10 minutes, including follow-up questions and a class discussion. A 2-page summary of the presentation to be submitted to the drop box. Additional information will be provided in class.

Group Interview Project 20% - Due Week 12 and 14 as assigned

Working in groups of 5 or 6, you will organize, prepare, and conduct an interview with a professional working within a specific area of alternative dispute resolution, arbitration, mediation, negotiation or restorative justice as assigned. This interview will take place in our classroom and will focus on the area of justice assigned to the interviewee as it relates to the concepts we have studied in this course. Details will be discussed in class and posted to D2L. Each group is to post an academic article on the type of justice practice to D2L the week prior to your presentation, for the class to read to prepare for the session. A summary of the presentation and learning to be submitted to D2L after the session.
