### Wellness Thought Paper and Plan – Due October 20, 2023 –

For this assignment, you will complete the Wellness Wheel Assessment and prepare a 2 to 3 page Thought Paper. The Thought Paper needs to reflect on your assessment of your current state of wellness and plans to enhance your wellness and well-being in the future. You will discuss the 7 dimensions of wellness and your well-being assessment, and identify 2 to 3 areas that are a priority for you and your plans are to enhance your wellness in those areas. What are your goals, and why? What specific things you will plan to do and how? Additional information will be provided on D2L and in class. Due October 20, 2023 day after class presentations. This assignment will also inform your career plan which will be complete in Crim 221.
