Assignment #1 - 15% - You will prepare and argumentative essay on one of the topics below.

An <u>argumentative essay</u> is one where you will investigate a topic; collect, generate, or evaluate evidence (i.e. research); and establish **your position and defend that position** in a **MINIMUM** length of 1000 words to a **MAXIMUM** length of 1250 words (equivalent to 4-5 double space pages), use APA standards, and contain at least 5 references. **Due date: February 8, 2024**.

Topics:

- 1) Decriminalization of drugs and the role of the Police. Specifically, argue for or against the decriminalization of drugs as it relates to the role of the police since the start of the decriminalized pilot project in British Columbia in January 2023.
- 2) Bail reforms in Canada. Specifically, argue whether the Bail reforms introduced in Bill C-48, which went into effect January 4, 2024, will be or not an efficient way to ensure a reduction in crime.

Assignment # 2 - 15% - You will prepare an <u>argumentative essay on the topics below.</u>

<u>An argumentative essay</u> is one where you will investigate a topic; collect, generate, or evaluate evidence (i.e. research); and establish **your position and defend that position** in a **MINIMUM** length of 1000 words to a **MAXIMUM** length of 1250 words (equivalent to 4-5 double space pages), use APA standards, and contain at least 5 references. **Due date: March 14, 2024**.

Topics:

- 1) Ideologically motivated Violent Extremism in Canada What is it? Is it a problem, Why or Why not? If it is, are there any specific groups that we should know about?
- 2) Indigenous and visible minorities views of police in Canada Is it a problem, Why or Why not? If it is, what are your suggested improvements?
- 3) Improving Police Efficiency in Canada What does police efficiency mean? Who should be involved? How do you measure it? How to improve it if it is needed?
