CALENDAR DESCRIPTION

Restricted to students in Cybersecurity & Networking Technology
Enterprise networks require staff to design, configure, install, operate and troubleshoot the network hardware such as routers and servers. Students will learn to describe the architecture and define considerations related to hardware selection for enterprise networks. Students will learn about wide area network (WAN) technologies and quality of service (QoS) mechanisms used for secure remote

access. They will learn key concepts of software-defined networking, cybersecurity, controller-based architectures, and how application programming interfaces (APIs) enable network automation.

- Configure single-area OSPFv2 in both point-to-point and multiaccess networks.
- Explain how to mitigate threats and enhance network security using access control lists and security best practices.
- Implement standard IPv4 ACLs to filter traffic and secure administrative access.
- Configure NAT services on the edge router to provide IPv4 address scalability.
- Explain techniques to provide address scalability and secure remote access for WANs.
- Explain how to optimize, monitor, and troubleshoot scalable network architectures.
- Explain how networking devices implement QoS.
- Implement protocols to manage the network.
- Explain how technologies such as virtualization, software defined networking, and automation affect evolving networks.

The following criteria must be met:

- Students must obtain a minimum weighted average of 60% in theory evaluations (tests, examinations etc.) in any course that is a pre-requisite for subsequent courses.

- Students must obtain a minimum weighted average of 60% in lab evaluations (lab performance, reports, etc.) in any course that is a pre-requisite for subsequent courses.
- Students must obtain a minimum of 50% on the final examination for a course in order to receive a passing grade.
- Failure to meet any one of these criteria will result in a student receiving a failing grade for the course.
- All assignments (laboratory work, reports, etc.) must be submitted prior to a student writing a final examination. ALL assignments must be submitted in order to qualify to write a final exam.
- Late assignments will be graded as zero. However, all assignment must be submitted.

COURSE GUIDELINES & EXPECTATIONS

- Attendance is expected for every class. Students who attend and participate do better than those that don't.
- A minimum of 50% (average) must be achieved in each of the theory and lab portions to pass the course. (60% for pre-requisites)
- **Less than 50% of total in either section will result in a failure of the entire course.
- Attendance is required for all scheduled Exams. Exams start at the beginning of class with no extra time to account for lateness.
- Labs are due according to the schedule. Late labs receive a grade of zero. Some labs require instructor sign-off for a grade.
- It is student responsibility to complete Quizzes on time. No additional time will be provided.
