COURSE SCHEDULE, TOPICS, AND ASSOCIATED PREPARATION / ACTIVITY / EVALUATION

The following schedule and course components are subject to change with reasonable advance notice, as deemed appropriate by the instructor A weekly schedule of classes will be posted on D2L.

ACTIVITY

Students are expected to attend all classes, small group sessions and engage sufficiently in order to safely apply theoretical content and concepts to the clinical environment. Students must be prepared to communicate and share knowledge and ideas with others; participate in discussion forums; self-evaluate, and provide constructive feedback to their peers. Pre-reading/preparation and attendance are essential in order to integrate the knowledge, skills, and expectations for professional behaviour from other courses and to make the learning experience meaningful. Missing three or more classes (> 10%) increases the risk for students to be unsuccessful in meeting the learning outcomes for this course.

Clients with Special Needs (refer to schedule for individual topics)

- Develop appropriate strategies for providing comprehensive dental hygiene care for clients with diverse medical and dental considerations including physical, developmental, and psychological limitations and impairments.
- Develop appropriate strategies for providing comprehensive dental hygiene care for clients with diverse medical and dental considerations related to chronic diseases and conditions.
- Identify signs and symptoms of family and domestic violence and the dental hygienist's legal and ethical responsibilities for reporting.
- Explore the dental hygienist's role in advocating for the protection of vulnerable populations.
- Explore palliative dental hygiene care in complex/long-term care.
- Develop appropriate strategies for working within an interdisciplinary care team for residents in complex/long-term care.
- Analyse non-surgical strategies to manage advanced periodontal disease for diverse clients
- Analyze periodontal suture materials and techniques for placement and removal.
- Discuss armamentarium, materials, and technique for placement and removal of a periodontal dressing

Adjunctive Caries Detection Devices

- Discuss various technologies available for dental caries detection.
- Compare the various devices currently on the market for caries detection.
- Explain information to discuss with the client regarding findings associated with an adjunctive device, including the need for follow-up and/or referral.
- Discuss the armamentarium and process for using a caries detection device.
- Discuss the use of resin infiltration within the dental hygiene scope of practice.
- Explain the process for placing a resin by infiltration on interproximal and facial surfaces.

Private Practice Transition

• Explore modifications to paperwork/documentation to transition into private practice

- Discuss Camosun College protocols for using condensed paperwork to document the ADPIE process.
- Discuss scheduling in private practice.
- Discuss strategies for effective delivery of comprehensive care in a timely manner
- Discuss potential issues entry-level dental hygienists may face when transitioning into practice
- Discuss fee for dental hygiene services in BC
- Discuss the challenges of the BCDA fee guide and dental insurance on the delivery of comprehensive dental hygiene care
- Discuss electronic software options for dental practice management including digital charting
- Discuss transitions into practice

Evaluate and Apply Professional Expectations for Entry-to-Pacific

- Demonstrate professionalism as a representative of the program and dental hygiene profession.
- Provide professional constructive feedback on the student experience in the DH program
