## CALENDAR DESCRIPTION

---

The student will examine and explore current and emerging theories and perspectives that explain human growth and development from conception to early childhood. Students will begin to reflect on their image of children and families through multiple lenses, including an introduction to Indigenous worldviews, to broaden their thinking about children and their growth. The impact of colonization and the residential school experience is explored to support decolonization and reconciliation. Theoretical knowledge will be considered in connection to relationship building with children and families and early childhood practice.

## CLASS GUIDELINES & EXPECTATIONS

---

Students will engage in the praxis of theory and practice within the rich child care centres they belong fulfilling coursework commitments as they move through individualized learning journeys. Learning outcomes will be explored alongside children, colleagues, families, instructors and the wider community.

Students are expected to participate with dispositions that include curiosity and wonder as they collect traces of practice (page 54 of the BC Early Learning Framework, 2019) and share learning with instructors, and classmates. In the sharing of experiences, students will connect practice back to theory and generate ongoing questions, and places for further inquiry.

Attending all scheduled meetings (community of practice, Learning Journey Plan meetings, and check-ins) will be an essential part of both a student's evolving professional practice and a mechanism for meeting all learning outcomes. Students are asked to inform instructors and community of practice members of absences, allowing for time to make plans enabling alternate possibilities to demonstrate learning.

Regular student/instructor meetings will occur at worksites over the term to share and celebrate the many ways learning is actively being demonstrated.

Students will be expected to demonstrate clear and professional communication with instructors and classmates at all times.

We will be offering Learning Journey plans with further course descriptions and tips as well as details regarding assessment through demonstration.
