Assignments

- 4. Should students receive a NC grade on an assignment, they will have one week from receiving the grade/feedback to <u>rewrite and resubmit</u>.
- 5. Follow APA writing guidelines where applicable. This includes formatting, spelling, grammar, in-text citations and references. Please remember to proof read for spelling and grammar.
- 6. It is the responsibility of each student to save a copy of all assignments until a final grade is received.

Please note: Getting behind in assignments and participation in seminars can put the student in jeopardy of being successful in completing the course. We encourage all students to be proactive by completing assignments on time and <u>immediately</u> communicating any difficulties to their practicum instructor.

- 1. Attending all Seminar classes and all scheduled Practicum days are required.
