COURSE SCHEDULE, TOPICS, AND ASSOCIATED PREPARATION / ACTIVITY / EVALUATION

Seminar Class: Students are required to notify their seminar instructor of any absences.

If a seminar is missed students are required to complete a "missed seminar" assignment and hand it in within four calendar days of the missed class, otherwise it will be counted as incomplete.

NOTE: If two seminars are missed, the student is at risk for not passing practicum, and must meet with the instructor and the Program Lead to discuss strategies for being successful in practicum.

STUDENT EVALUATION

Assignments and Evaluation

A detailed description of assignments will be made available online and discussed in class.

Students will be evaluated primarily based on their performance in the practicum setting and completion of assignments and learning outcomes. Evaluation will be based on performance, not potential; the mentor in the field will be aware that this is a process with consistent competency as the final goal.

Students will need to meet all learning outcomes to receive a passing grade (COM). Students will receive help and suggestions and be encouraged to consider their own performance, both in discussions with the field placement mentor and in weekly Practicum seminars. The Camosun College instructors will schedule visits to the facility and be available for discussions. Working well in your placement setting is the most important indicator of suitability for this field. A grade of C+ is required to be successful in the ELC program.
