COURSE LEARNING OUTCOMES

Upon successful completion of this course a student will be able to:

- a) use critical thinking skills in the ongoing, dynamic creation and reflection of early learning and care practices.
- b) support young children's well-being and holistic learning within the context of family, culture, and community.
- c) establish, maintain, evaluate and adapt inclusive, nurturing, safe and healthy environments which exceed the requirements of current legislation, regulatory bodies and program policies.
- d) use respectful, professional interpersonal and culturally appropriate communication skills in all aspects of work as an early learning and care professional.
- e) develop meaningful relationships with young children, families, and colleagues as a foundation for early learning and care practice.
- f) demonstrate basic knowledge of indigenous ways of knowing and being, including the impact of on-going colonization and the skills of reconciliation and that enable supportive early learning experiences for aboriginal children, families and community.
- g) demonstrate professional responsibility and accountability as an early childhood educator by adhering to the Early Childhood Code of Ethics (principles of fairness, equity and diversity).

COURSE SCHEDULE, TOPICS, AND ASSOCIATED PREPARATION / ACTIVITY / EVALUATION

Students are required to attend all practicum sessions in the field and all classroom seminars unless they have a legitimate medical reason.

Students are required to attend practicum a minimum 3 days a week, 15 hours a week, for twelve weeks.

Practicum: Students must notify both the Mentor and Instructor prior to any absences. If you are suddenly too sick to attend practicum, *both* the centre and your instructor must be contacted that morning.

All missed hours will need to be made up; students must connect with the College instructor within one week of absences to plan for make-up hours.

NOTE: Missing more than 4 practicum days will result in a no credit, however your instructor and mentor will try and support you in getting the needed hours. In case of a serious illness, a student will be able to apply for a medical withdraw.

Seminar Class: Students are required to notify their seminar instructor of any absences.

If a seminar is missed students are required to complete a "missed seminar" assignment and hand it in within four calendar days of the missed class, otherwise it will be counted as incomplete.

NOTE: If two seminars are missed, the student is at risk for not passing practicum, and must meet with the instructor and the Program Lead to discuss strategies for being successful in practicum

STUDENT EVALUATION

Assignments and Evaluation

A detailed description of assignments will be handed out and discussed in class.

Students will be evaluated primarily based on their performance in the practicum setting and completion of assignments and learning outcomes. Evaluation will be based on performance, not potential; the mentor in the field will be aware that this is a process with consistent competency as the final goal.

Students will need to *meet all learning outcomes* to receive a passing grade (COM). Students will receive help and suggestions and be encouraged to consider their own performance, both in discussions with the field placement mentor and in weekly Practicum seminars. The Camosun College instructors will schedule visits to the facility and be available for discussions. Working well in your placement setting is the most important indicator of suitability for this field.

All assignments must be completed before a grade will be assigned. All *practicum outcomes* must be demonstrated at a C+ level or higher, and *each assignment* must be completed by the due date at a C+ level or higher to be considered "complete". Assignments may be sent back if they are not a C+ level or better.

Assignments are expected on the due date. Extensions must be negotiated with your instructor prior to due dates. Opportunity to rewrite assignments supports articulation of ELC knowledge, skills and attitudes. Late assignments submitted in the last week of term will not have the opportunity for rewrites.

The Camosun instructor makes the final decision whether a student has been successful with their practicum experience. Final grading is either a "COM" for Completed or "NC" for Not Completed.

Students are expected to notify the college instructor and mentor of any situation that is interfering with their ability to fully participate in practicum.

Students will be withdrawn from a practicum placement for behavior which endangers the health, safety or well- being of the children or staff.
