## CALENDAR DESCRIPTION

Students are introduced to the principles of microeconomic analysis. They will learn how markets function and how changes in consumer preference, production technology, and resource availability affect the prices and quantities of goods.

## COURSE LEARNING OUTCOMES / OBJECTIVES

1. Explain fundamental concepts applicable to economic problems.
2. Analyze and calculate the impact of market conditions and/or government policies on market equilibrium.
3. Calculate and interpret elasticity as a measure of the responsiveness of demand or supply to changes in income, the product's own price, and price of other products.
4. Apply consumer theory to determine optimal quantity of goods purchased
5. Calculate various cost measures; and identify the relationship between them.
6. Explain how efficiency is impacted by different market structures and how markets reach equilibrium.
7. Explain and analyze the role of comparative advantage in international trade and explain effects of different trade policies.
8. Apply microeconomic reasoning to explain current events.

## COURSE GUIDELINES & EXPECTATIONS

---

This course is delivered using a HyFlex model. This means that students can choose to navigate through the asynchronous materials without attending class, OR they can attend classes for directed instruction. Students who attend class will benefit greatly by reviewing the online videos and supports prior to each session. The class sessions will review the week's material, but will focus on opportunities to practice through application of the models in algebraic examples.

Students registered in 004 can choose to complete the exams online and students in D06 and D07 can choose to attend lectures and exam dates as desired. Students must let me know how they plan to complete assessments ahead of the exam date(s).

I have been teaching HyFlex courses for over a year now, but this is the first year I am teaching ECON 103 with this model. I want to make sure everyone has the same opportunities to learn. If you feel there could be improvements in delivery or support materials, please let me know.
