## CALENDAR DESCRIPTION

Students are introduced to the principles of microeconomic analysis. They will learn how markets function and how changes in consumer preferences, production technology, and resource availability affect the prices and quantities of goods.

## COURSE LEARNING OUTCOMES / OBJECTIVES

---

1. Explain fundamental concepts applicable to economic problems.
2. Analyze and calculate the impact of market conditions and/or government policies on market equilibrium.
3. Calculate and interpret elasticity as a measure of the responsiveness of demand or supply to changes in income, the product's own price, and price of other products.
4. Apply consumer theory to determine optimal quantity of goods purchased
5. Calculate various cost measures; and identify the relationship between them.
6. Explain how efficiency is impacted by different market structures and how markets reach equilibrium.
7. Explain and analyze the role of comparative advantage in international trade and explain effects of different trade policies.
8. Apply microeconomic reasoning to explain current events.

## COURSE GUIDELINES & EXPECTATIONS

### Quizzes:

Throughout the semester you will take several quizzes on the MyEconLab platform. Before you attempt a quiz, I strongly encourage you to review the questions from the respective chapters in the Study Plan and Dynamic Study Modules in MyEconLab.

The exact quiz due dates will be determined in class depending on topic coverage. The deadline and chapters for each quiz will be announced on D2L after the quiz posted on MyEconLab. You will be given few days to complete each quiz.

The lowest one (1) quiz mark will be dropped and the rest will determine your total quiz grade. You will have 3-5 attempts – your best attempt will be used for your grade. Each quiz is “open book” and you have unlimited time to complete it before the due date. You can review your quiz results at any time after the due date.

There will be no-make-ups for missed quizzes. If you miss a quiz, it will count as the worst quiz to drop. Note, if you miss more than one quiz, ONLY one will be dropped, the other missed quiz will get a mark zero and count toward overall quiz grade.

## Exams:

The midterm exam dates are given in the course schedule above. The final exam will be scheduled by Student Services and will take place during the final exam period. The final exam is NOT cumulative. Students will be allowed to bring 2 pages (1 sheet) of written notes to use during in-class exams. Higher percentage of final exam reflects the rigour and complexity of content. Review guidelines, practice questions and other details for each exam will be posted on D2L.

**Deadlines:** You must submit your assignments on the due date or as announced. A grade of zero will be assigned to late submissions. There are no additional assignments or make-up exams of any kind if you performed poorly on an assignment, midterm or final exam.

1. a) EXAM DATES WILL NOT BE RESCHEDULED. Non-attendance on scheduled exam dates results in a zero grade. Exceptions will be made only for medical reasons or extenuating circumstances that must be submitted and then accepted by the instructor. Please advise your instructor promptly.
