Students are introduced to the principles of microeconomic analysis. They will learn how markets function and how changes in consumer preferences, production technology, and resource availability affect the prices and quantities of goods.

COURSE LEARNING OUTCOMES / OBJECTIVES

1. Explain fundamental concepts applicable to economic problems.
2. Analyze and calculate the impact of market conditions and/or government policies on market equilibrium.
3. Calculate and interpret elasticity as a measure of the responsiveness of demand or supply to changes in income, the product's own price, and price of other products.
4. Apply consumer theory to determine optimal quantity of goods purchased
5. Calculate various cost measures; and identify the relationship between them.
6. Explain how efficiency is impacted by different market structures and how markets reach equilibrium.
7. Explain and analyze the role of comparative advantage in international trade and explain effects of different trade policies.
8. Apply microeconomic reasoning to explain current events.

COURSE GUIDELINES & EXPECTATIONS

Lectures

This course is scheduled in-person on Mondays and Wednesdays 2:30-4:30 in Fisher 334, Lansdowne campus. It is important to attend all lectures and participate in the in-class activities. In addition to going over the topic scheduled for that day, we will do practice questions and you will have an opportunity to ask questions regarding the upcoming quizzes, discussion forums, and exams. Information regarding the course will be provided in class.

D2L site for the course:

You will find a companion site for this course on the Learning Management System platform – Desire to Learn (D2L). For your convenience, I have included online course materials in D2L, however, this does not replace the expectation to attend class as most of the course information will be provided during class.

In the Content section in D2L you will find modules corresponding to each week of the semester as well as a general Course Information Module. The weekly modules contain pre-recorded lecture videos, power point notes, chapter summaries, and practice questions videos and solution notes. The Course Information Module contains the course outline as well as registrations instructions for MyEconLab.

The interim grades during the term will be posted on D2L. The final letter grade for the course will be posted in myCamosun.

I strongly encourage you to set up your notifications on D2L to receive timely updates.

Quizzes:

Throughout the semester you will take 7 quizzes on the MyEconLab platform. Each quiz covers approximately 2 chapters. The purpose of the quizzes is to help you keep up with the material and prepare for the exams. Before you attempt a quiz, I strongly encourage you to review the questions from the respective chapters in the Study Plan in MyEconLab. The Study Plan is interactive and provides you with solutions and explanations.

The quiz due dates and times are given in the course schedule above. Each quiz will open on a Tuesday and you will have until Monday of the following week to complete it (except the last quiz which is due on the last day of the semester).

The lowest two quiz marks will be dropped and the rest will determine your total quiz grade. You will have 3 attempts and unlimited time for each quiz – your best attempt (of the three) will be used for your grade. Each quiz is “open book” and you have unlimited time to complete it before the due date. You can review your quiz results at any time after the due date.

There will be no-make-ups for missed quizzes. If you miss a quiz, it will count as one of your dropped quizzes.

Discussion Forums:

During the term you will participate in several discussion forums which are set up in D2L. Each forum is dedicated to a specific topic in the course. This is an opportunity to research and discuss the application of the course concepts for analysing business decision-making, consumer choices and government regulation. Each forum will open and close in the respective week given in the course outline. Additional guidelines about discussion forum posts and participation will be provided in D2L.

Exams:

The midterm exam date is given in the course schedule above. The midterm exam is an in-class exam. The final exam will be scheduled by Student Services and will take place online during the final exam period. The exams are not cumulative. The approximate coverage for each exam is as follows:

Midterm exam – Chapters 1, 2, 3, 4, 5, 6, and 16.3

Final exam – Chapter 17, 32, 7, 8, 9, 10, 11, 12

The exam questions are similar to the Practice Questions we cover in each chapter as well as the Quiz questions in MyEconLab. The exams are “open book”. Guidelines about exam preparation will be discussed closer to the scheduled exam dates.

SCHOOL OR DEPARTMENTAL INFORMATION

This course is offered by the School of Business - the Department of Economics, Quantitative Methods and University Transfer. It is a required course for many Business programs and for the Associate of Arts Degree in Economics. It is also a popular elective for many University Transfer students.

The Associate of Arts Degree in Economics and the University Transfer Business stream offer significant flexibility in course selection.
