Upon successful completion of this course, students will be able to:

Explain the concepts of scarcity, choice, and opportunity cost using the possibilities model.

Construct the model of demand and supply, and analyze the impact of economic conditions or government policy on the market's equilibrium.

Use and interpret elasticity as a measure of the responsiveness of demand to changes in the product's own price, income, and prices of other goods.

Apply consumer theory to determine optimal quantity of goods purchased.

Calculate total, fixed, variable, average and marginal costs; and demonstrate the relationships among them.

Determine the optimal levels of output for firms in different market structures and illustrate the impact of each market structure on economic efficiency.

Analyze the role of comparative advantage in international trade-and explain effects of different trade policies in the market.
