## CALENDAR DESCRIPTION

Students are introduced to the principles of microeconomic analysis. Students They will learn how markets function, and how changes in consumer preference, production technology, and resource availability affect the prices and quantities of goods.

- 1. Explain fundamental concepts applicable to economic problems.
- 2. Analyze and calculate the impact of market conditions and/or government policies on market equilibrium.
- 3. Calculate and interpret elasticity as a measure of the responsiveness of demand or supply to changes in income, the product's own price, and price of other products.
- 4. Apply consumer theory to determine optimal quantity of goods purchased
- 5. Calculate various cost measures; and identify the relationship between them.
- 6. Explain how efficiency is impacted by different market structures and how markets reach equilibrium.
- 7. Explain and analyze the role of comparative advantage in international trade and explain effects of different trade policies.
- 8. Apply microeconomic reasoning to explain current events.

# COURSE GUIDELINES & EXPECATIONS

**Exams:** Your mastery of the course learning outcomes will primarily be assessed using 3 equally weighted exams. The exams are NOT explicitly cumulative and their coverage is as follows:

- Exam 1 (Units 1 to 4) July 21 to 22
- Exam 2 (Units 5 and 6) August 11 to 12
- Exam 3 (Units 7 to 10) August 22 to 23

The exams are administered online and may be completed remotely. Each exam will be available to you for a 48-hour period, on the dates posted above. You may choose when during these 48-hour periods you would like to write the exam; however, the exams are limited to 2 hours duration once started and must be completed prior to the closure of the exam window. Additional information regarding the examination format and materials allowed will be provided on the course website (D2L).

**Quizzes:** You will complete up to 7 quizzes during the semester. The quizzes are administered through the My Econ Lab platform (this is an essential component of the course) and account for 25% of your course grade. You may take up to 3 attempts on each quiz (only your best score from those attempts will be retained), and at the end of the semester I will remove your 2 worst quiz scores (i.e. when I'm calculating your final grade, I'll count your 5 best quizzes only). Except for the last one, quizzes are due in the week following their availability in the schedule. E.g. Quiz 1 is due before the end of the second week (Sunday, July 17), Quiz 2 is due the week after that (Sunday, July 24) and so on. The last quiz is due by the end of the day on August 23. Quiz due dates will not be extended under any circumstances.
