Students are introduced to the principles of microeconomic analysis. They will learn how markets function and how changes in consumer preferences, production technology, and resource availability affect the prices and quantities of goods.

1. Explain fundamental concepts applicable to economic problems.
2. Analyze and calculate the impact of market conditions and/or government policies on market equilibrium.
3. Calculate and interpret elasticity as a measure of the responsiveness of demand or supply to changes in income, the product's own price, and price of other products.
4. Apply consumer theory to determine optimal quantity of goods purchased
5. Calculate various cost measures; and identify the relationship between them.
6. Explain how efficiency is impacted by different market structures and how markets reach equilibrium.
7. Explain and analyze the role of comparative advantage in international trade and explain effects of different trade policies.
8. Apply microeconomic reasoning to explain current events.

COURSE GUIDELINES & EXPECTATIONS

D2L site for the course:

You will find a companion site for this course on the Learning Management System platform – Desire to Learn (D2L). I strongly encourage you to become familiar with the materials available on this site and check the site regularly for updates. I use the News feature to make announcements and provide course updates.

In the Content section you will find modules corresponding to each week of the semester as well as a general Course Information Module. The weekly modules contain pre-recorded lecture videos, power point notes, chapter summaries, and practice questions videos and solution notes.

The interim grades during the term will be posted on D2L.

I strongly encourage you to set up your notifications on D2L to receive timely updates.

Quizzes:

Throughout the semester you will take 7 quizzes on the MyEconLab platform. Each quiz covers approximately 2 chapters. The purpose of the quizzes is to help you keep up with the material and prepare for the exams. Before you attempt a quiz, I strongly encourage you to review the questions from the respective chapters in the Study Plan in MyEconLab. The Study Plan is interactive and provides you with solutions and explanations

The quiz due dates and times are given in the course schedule above. Each quiz will open on a Tuesday and you will have until Monday of the following week to complete it (except the last quiz which is due on the last day of the semester).

The lowest two quiz marks will be dropped and the rest will determine your total quiz grade. You will have 3 attempts and unlimited time for each quiz – your best attempt (of the three) will be used for your grade. Each

quiz is “open book” and you have unlimited time to complete it before the due date. You can review your quiz results at any time after the due date.

There will be no-make-ups for missed quizzes. If you miss a quiz, it will count as one of your dropped quizzes.

Discussion Forums:

During the term you will participate in several discussion forums which are set up in D2L. Each forum is dedicated to a specific topic in the course. This is an opportunity to research and discuss the application of the course concepts for business decision-making, consumer choices and government regulation. Each forum will open and close in the respective week given in the course outline. Additional guidelines about discussion forum posts and participation will be provided in D2L.

Exams:

The midterm exam dates and times are given in the course schedule above. All exams are online and will be administered through the MyEconLab platform. The final exam will be scheduled by Student Services and will take place during the final exam period. The exams are not cumulative. The approximate coverage for each exam is as follows:

Midterm 1 – Chapters 1, 2, 3, 4

Midterm 2 – Chapters, 5, 6, 7, 8, 16.3, 17, 32

Final exam – Chapter 9, 10, 11, 12

The exam questions are similar to the Practice Questions I have identified for each chapter as well as the Quiz questions in MyEconLab. All exams are “open book”. Guidelines about exam preparation will be discussed closer to the scheduled exam dates.
