CALENDAR DESCRIPTION

Students are introduced to the principles of macroeconomic analysis. Using theoretical models of national income and business cycles, they will analyze the impact of government policy on interest rates and exchange rates, and economic growth.

COURSE LEARNING OUTCOMES / OBJECTIVES

1. Explain the income and expenditure approaches for measuring the economy's output; distinguish between real and nominal GDP.
2. Develop the aggregate expenditure model for a closed and an open economy in order to explain the multiplier effect and government fiscal policy.
3. Construct the aggregate demand and aggregate supply model and use them to explain short-run economic fluctuations, the impact of government monetary and fiscal policy, and the adjustment of the economy over time.
4. Explain the derivation of the unemployment and inflation statistics and determine the relationships between inflation, employment and income in the context of the macroeconomic models.
5. Analyze the short and long-run effects of government budget surpluses and deficits and the public debt on the economy.
6. Analyze currency markets and the balance of payments to determine a country's position in international markets.
7. Identify the factors contributing to long-run economic growth in the context of the different growth models.

COURSE GUIDELINES & EXPECTATIONS

Quizzes:

Throughout the semester you will take six quizzes on the MyEconLab platform. Your best five quizzes will be used for the final grade. Before you attempt a quiz, I strongly encourage you to review the questions from the respective chapters in the Study Plan in MyEconLab.

The quiz due dates are given in the course outline. Each quiz opens one week prior to the due date (you have one week to complete each quiz.)

You will have 3 attempts and unlimited time (during the week the quiz is open) to complete each quiz. Your best attempt (of the three) will be automatically used for your grade. Each quiz is “open book”. You can review your quiz results in Myeconlab after the due date.

There will be no-make-ups for missed quizzes. If you miss a quiz, it will count as your dropped quiz.

Discussion Forums:

During the term you will participate in three discussion forums which are set up in D2L. Your best two discussion marks will be used for the final grade. Each forum is dedicated to a specific topic in the course. This is an opportunity to research and discuss the application of the course concepts for analysing business decision-making, consumer choices and government regulation. Each forum will open and close in the respective week given in the course outline. Additional guidelines about discussion forum posts and participation will be provided in D2L.

Note that each discussion takes place in two parts – in the first part, you will prepare and submit your answer to the discussion question by Friday at 11:59pm of the respective week; in second part, you will review the submissions and prepare a response by Monday 11:59pm of the respective week. There will be no make-ups for missed discussion forums. If you miss one discussion it will count as your dropped one.

Before starting the first discussion forum, you will complete a short online course on Academic Integrity (approximately 45min) through the Camosun Library. This course will help you understand better the expectations around academic integrity. I will assign bonus marks for completing the course prior to the first discussion forum. More information about accessing the academic integrity course will be provided in D2L.

Exams:

The midterm exam dates and time is given in the course schedule above.

The final exam will be scheduled by Student Services and will take place online during the final exam period.

The midterm exams are not cumulative. The final exam will focus on the last three chapters and key concepts from the course content as discussed in class. The approximate coverage for each exam is as follows:

Midterm exam 1 - Chapters 4, 5, 6, and 7

Midterm exam 2 – Chapters 8, 9, 11 and 12

Final exam – Chapters 13, 16, 19 and selected key concepts

The exam questions are similar to the Practice Questions we cover in each chapter as well as the Quiz questions in MyEconLab. The exams are “open book”. Guidelines and suggestions about exam preparation will be discussed closer to the scheduled exam dates.

This course is offered by the School of Business - the Department of Economics, Quantitative Methods and University Transfer. It is a required course for many Business programs and for the Associate of Arts Degree in Economics. It is also a popular elective for many University Transfer students.
