CALENDAR DESCRIPTION

Students are introduced to the principles of macroeconomic analysis. Using theoretical models of national income and business cycles, they will analyze the impact of government policy on interest rates and exchange rates, and economic growth.

PREREQUISITES: One of: C in Foundations of Math 11; C in Pre-calculus 11; C in MATH 077; C+

in MATH 072 or C+ in MATH 075

One of: C in English 12 or Camosun alternative (see Calendar)

- 1. Explain the income and expenditure approaches for measuring the economy's output; distinguish between real and nominal GDP.
- 2. Develop the aggregate expenditure model for a closed and an open economy in order to explain the multiplier effect and government fiscal policy.
- 3. Construct the aggregate demand and aggregate supply model and use them to explain short-run economic fluctuations, the impact of government monetary and fiscal policy, and the adjustment of the economy over time.
- 4. Explain the derivation of the unemployment and inflation statistics and determine the relationships between inflation, employment and income in the context of the macroeconomic models.
- 5. Analyze the short and long-run effects of government budget surpluses and deficits and the public debt on the economy.
- 6. Analyze currency markets and the balance of payments to determine a country's position in international markets.
- 7. Identify the factors contributing to long-run economic growth in the context of the different growth models.

COURSE GUIDELINES & EXPECTATIONS

Quizzes:

Throughout the semester you will complete six quizzes on the MyEconLab platform. The purpose of the quizzes is to help you keep up with the pace of the course and prepare for the exams.

Your <u>best five</u> quizzes will be used for the final grade. Before you attempt a quiz, I strongly encourage you to review the questions from the respective chapters in the Study Plan in MyEconLab.

The quiz due dates are given in the course outline. Each quiz opens one week prior to the due date (you have one week to complete each quiz.)

You will have 3 attempts and unlimited time (during the week the quiz is open) to complete each quiz. Your best attempt (of the three) will be automatically used for your grade. Each quiz is "open book". You can review your quiz results in Myeconlab after the due date.

There will be no-make-ups for missed quizzes. If you miss a quiz, it will count as your dropped quiz.

In-class interactive activities:

Each Friday, starting in week 2 to week 13 of the semester (except on Oct. 4 and Nov.8 when the midterm exams are scheduled) we will have time set aside for an in-class interactive activity related to the topic currently covered in the course. This is an applied learning opportunity, where you will apply concepts and theories currently covered in the course to analyzing current events in the economy. For each interactive activity, I will select and post in D2L a short article or assignment that will be used as a basis for the discussion and will formulate several questions for discussion. You will have an opportunity to review the materials and

the assignment before class. During class, you will first address the discussion questions within you small team and then share with the rest of the class. Each person will also submit brief written answers to the discussion questions. The answers will be marked on a Pass/Fail basis. Marking criteria include familiarity with the assigned reading and applying respective course concept to address the discussion question. Answers generated by artificial intelligence will not be accepted.

Exams:

All exams are in person. You will need a calculator for all exams.

The midterm exam dates and time is given in the course schedule above.

The final exam will be scheduled by Student Services and will take place in person during the final exam period. The midterm exams are not cumulative. The final exam will focus on the last three chapters and key concepts from the course content as discussed in class. The approximate coverage for each exam is as follows:

Midterm exam 1 - Chapters 4, 5, 6, and 7

Midterm exam 2 – Chapters 8, 9, 11 and 12

Final exam – Chapters 13, 16, 19 and selected key concepts

The exam questions are similar to the Practice Questions we cover in each chapter as well as the Quiz questions in MyEconLab. During all exams you may use paper-based summary notes. Guidelines and suggestions about exam preparation will be discussed closer to the scheduled exam dates.

Academic integrity and use of artificial intelligence:

At the start of the course, everyone will have an opportunity to complete the Academic Integrity course through the Camosun Library (you will find instructions in D2L and I will also explain in class). The course provides explanations and examples of academic integrity. It is free and takes under an hour to complete online. You will receive 2 bonus marks upon submitting proof of completion (as outlined in D2L).

Artificial intelligence and its use in education (and elsewhere) have been widely discussed lately. The policy on the use of AI in this course is as follows: It is perfectly fine to use and benefit from the capabilities of AI to assist in your learning, look up information, seek explanation of concepts, examples, etc. However, running assignment questions through AI and presenting the answer as your own ("copy and paste") constitutes cheating and will be reported as such under the policy on academic integrity:
