CALENDAR DESCRIPTION

Students are introduced to the principles of macroeconomic analysis. Using theoretical models of national income and business cycles, they will analyze the impact of government policy on interest rates and exchange rates, and economic growth.

COURSE LEARNING OUTCOMES / OBJECTIVES

1. Explain the income and expenditure approaches for measuring the economy's output; distinguish between real and nominal GDP.
2. Develop the aggregate expenditure model for a closed and an open economy in order to explain the multiplier effect and government fiscal policy.
3. Construct the aggregate demand and aggregate supply model and use them to explain short-run economic fluctuations, the impact of government monetary and fiscal policy, and the adjustment of the economy over time.
4. Explain the derivation of the unemployment and inflation statistics and determine the relationships between inflation, employment and income in the context of the macroeconomic models.
5. Analyze the short and long-run effects of government budget surpluses and deficits and the public debt on the economy.
6. Analyze currency markets and the balance of payments to determine a country's position in international markets.
7. Identify the factors contributing to long-run economic growth in the context of the different growth models.

Assignments

Quizzes

You will be assigned two quizzes in MindTap. Each quiz will cover the material from one or several chapters. The quiz will be open on the due date stated in the table above. You will have 2 attempts for each question but may submit each quiz only once. Your best score for each question will be used for your grade.

Midterm Exams/ Final test

The exams consist of a combination of short answer, MCQs, longer scenario-based questions and essay questions. Additional information, including material covered on each exam, time allocation, how to best prepare, etc. will be provided in class and in D2L close to the exam dates.

Group Discussion

You will be given two discussion topics based on a case study or reading. You will work with other group members to analyze and comment on the discussion forum by the due date mentioned in the table above.
