# CALENDAR DESCRIPTION

Students will use the theories of national income to analyze the impact of shocks and economic policy on employment, inflation, growth, and the business cycle, for closed and open economies.

PREREQUISITE(S): C in ECON 103 and 104 C in EITHER MATH 100 OR MATH 108 Upon successful completion of this course, a student will be able to:

- 1. Interpret major economic indicators and statistics like Gross Domestic Product, the Consumer Price Index, the GDP Deflator, and the unemployment rate.
- 2. Explain the level of GDP, its distribution, and long-run equilibrium using the model of national income determination.
- 3. Demonstrate the impact of the rate of saving, population growth, and technological progress on economic growth using the Solow growth model.
- 4. Derive the determinants of the steady state rate of unemployment, and analyze situations in which wage rigidity contributes to unemployment.
- 5. Explain the functions of money, the quantity theory of money, the inflation tax, and the Fisher effect.
- 6. Evaluate the impact of shocks to the economy and the role of stabilization policy using the aggregate demand and aggregate supply model.
- 7. Develop the IS-LM model from the Keynesian cross and the theory of liquidity preference and use the model to explain economic fluctuations.
- 8. Show how monetary and fiscal policy affects the economy under floating and fixed exchange rates using the Mundell-Fleming model.

## COURSE GUIDELINES & EXPECTATIONS

This course is delivered using a *HyFlex* model. This means that students can choose to navigate through the asynchronous materials without attending class, OR they can attend classes for directed instruction. Students in section 001 will benefit greatly by reviewing the online videos and supports prior to class attendance. The class sessions will review the week's material, but will focus on opportunities to practice through application of the models in algebraic examples.

Students registered in 001 can choose to complete the exams online and students in D01 can choose to attend lectures and exam dates as desired. Students must let me know how they plan to complete assessments ahead of the exam date(s).

This is only the second *HyFlex* course I am teaching, and I want to make sure everyone has the same opportunities to learn. If you feel there could be improvements in delivery or support materials, please let me know.

There is a great deal of information provided to prepare you for the course, and a checklist to guide you through the course work. Since the first checklist item states "read the course outline", I should now make it worth your while to do so. The discussion tab in the D2L page has main discussion forum. In that forum there is a topic "Please only respond here if you have been asked to". If you would like an extra bonus point for the course, simply reply to my initial thread with the answer "I like to follow the directions". I will award a bonus point for every person who posts prior to 17 January.
