## CALENDAR DESCRIPTION

---

Students will apply fundamental models in economics to the context of sports management and planning. They will examine how market structure pertains to franchises, organizations and competition. Students also learn about the practical applications of profit maximization, including the value of leagues, and international organizations, and the external impact of events on communities. Students will also determine how salary caps and other labor bargaining tools affect competition in the boardroom and on the field.

Upon successful completion of this course, students will be able to:

- Apply concepts in economics to the planning and management of sporting events (e.g. North American Indigenous Games), facilities, and leagues.
- Identify how financial, human and physical resources affect operation of an event or facility.
- Examine market structure to make informed and strategic decisions in a variety of contexts.
- Describe how themes in economics in the setting of sports management support organizational goals.
- Examine the effect of events and facilities on the community using a model of externalities.
- Identify the impact of policies and practices imposed by leagues, associations and the government.

### D2L Quizzes

### Midterm Exam

The midterm exam will test your understanding of the following topics: Introduction to Economics, The Supply and Demand Model, Theory of the Firm I: Production and Costs, and Theory of the Firm II: Profit Maximization. ### Data Analysis Assignment

The data analysis assignment will be based on your understanding of the Introduction to Regression Analysis and will require you to use Microsoft Word and Microsoft Excel.

### PowerPoint Project

Information regarding the PowerPoint project will be discussed in class and made available on D2L during week 10.

### Final Exam

The final exam will test your understanding of the following topics: Industrial Organization of Sports I, Industrial Organization of Sports II, The Public Finance of Sports, and The Labor Economics of Sports.
