Students will gain the skills needed to work effectively with the AutoCAD Electrical software. They will learn how to use the software tools to create schematic drawings, ladder logic diagrams, point to point diagrams, panel drawings, and PLC I/O circuits using automated commands for symbol insertion, component tagging, wire numbering, and drawing modification. Students will learn how to customize AutoCAD Electrical symbols, circuits, and databases. Additional topics covered include: title block linking, reporting tools, templates, and project files.

## Upon successful completion of this course, a student will be able to:

- Produce electrical drawings using AutoCAD Electrical design software.
- Apply automated commands to enable symbol insertion, component tagging, wire numbering, and drawing modification.
- Construct unique electrical symbols, circuits, and databases using the customizing features of AutoCAD.
- Generate professional industry standard documents using title block linking, reporting tools, templates, and project files.

#### **COURSE GUIDELINES & EXPECTATIONS**

- Class/labs attendance is mandatory
- Students must obtain a minimum weighted average of 60% in theory evaluations (tests, examinations etc.) in any course that is a pre-requisite for subsequent courses
- Students must obtain a minimum weighted average of 60% in lab evaluations (lab performance, reports, etc.) in any course that is a pre-requisite for subsequent courses
- Students must obtain a minimum of 50% on the final project for a course in order to receive a passing grade
- Failure to meet any one of these criteria will result in a student receiving a failing grade (F) for the course
- All course work must be submitted prior to a student starting the final project
- Late assignments will have marks deducted; if handed in after assignments are returned to the class, then
  no mark will be awarded
  - Late penalties of 50% and 5% per day will be applied
  - A 20% penalty will be applied to current lab mark for Late Attendance
