## CALENDAR DESCRIPTION

---

Students will study transducer interfacing, signal conditioning, power supplies and regulators, and energy harvesting devices in this course. They will also learn applications of operational amplifiers, with a focus on analog filters, and audio circuit fundamentals.

- construct and analyze op amp circuits including amplifiers, limiters and oscillators.

- set up suitable power supplies for operational amplifiers in a variety of configurations.
- describe the operation of transducers and design transducer circuitry and signal conditioning circuits.
- design and construct a simple power supply and evaluate its percentage regulation.
- construct and test operational amplifier and transduction circuits.
- explain the operation of energy harvesting devices.
- select and design a filter to meet a design specification.
- explain the operation of audio circuits.
- use test equipment and diagnostic procedures to verify and troubleshoot circuits.
- follow prescribed safety procedures appropriate to an electronics laboratory.

## COURSE GUIDELINES & EXPECTATIONS

---

- Attendance to all labs is **mandatory**.
- You are expected to arrive at the lab on time with the necessary tools etc. Marks will be deducted for excessive tardiness and lack of preparation.
- Students must obtain a minimum weighted average of **60% in theory evaluations** (tests, examinations etc.) in any course that is a pre-requisite for subsequent courses.
- Students must obtain a minimum weighted average of **60% in lab evaluations** (lab performance, reports, etc.) in any course that is a pre-requisite for subsequent courses.
