## CALENDAR DESCRIPTION

---

Students will be introduced to the fundamentals of power electronic devices needed for industrial motor control, such as inverters, rectifiers, power diodes, thyristors, and switches. Students will learn how to control the speed and operation of DC and AC, single and polyphase motors. The course provides students opportunities to apply the knowledge and skills needed to specify the necessary equipment to manage and operate motors and motor drives.

#### COURSE LEARNING OUTCOMES / OBJECTIVES

Upon successful completion of this course a student will be able to:

1. Describe the characteristics and operation of power control devices and industrial electronic circuits.
2. Classify power devices according to speed, power, and control type.
3. Interpret power device specifications and specify power devices for a given application.
4. Calculate power device losses to specify appropriate heat-sink requirements
5. Explain the fundamental concepts of three phase power systems and grid-tying.
6. Describe the operation of AC and DC motors/generators, inverter circuits, controlled rectifier circuits, and DC and AC motor drives.
7. Describe the operation of circuits involving power diodes, thyristors, and controlled switches used in motor drive systems
8. Determine strategies for the protection and isolation of power devices
9. Perform calculations to determine suitable component values for power circuits.
