# CALENDAR DESCRIPTION

Students will study analog voice and data communications as used in the marine industry. They will learn radio frequency analysis, radio frequency (RF) components, amplitude modulation (AM) and frequency modulation (FM) techniques, single side band (SSB) transmission, transmission lines, RF propagation and noise. Students will be introduced to marine radios and learn about the choice of frequencies, as well as Digital Selective Calling, the Global Maritime Distress and Safety System, (DSC/GMDSS).Students will make extensive use of RF test equipment, including spectrum analyzers, and simulation techniques during lab exercises.

- Measure the characteristics of radio equipment using standard RF test equipment.
- Describe the properties, behaviour, and correct termination of transmission lines.
- Describe characteristics of antennas and analyze antenna radiation patterns.
